### **Msunduzi Municipal Business Investment Incentive Policy**

Prospective investors, business owners, and the community within the jurisdiction of the municipality. You are invited to apply for the Msunduzi Municipal Investment and Business Incentives.

Msunduzi Municipal Investment and Business Incentive scheme's intent is to empower the municipality with an additional tool for attracting, new and expanding investments into the Municipality.

#### **ELIGIBLE CRITERIA AND APPLICATION REQUIREMENTS:**

The investment/business must meet the following application criteria within the Financial Year 2024/2025.

The following criteria will be applied to determine investor eligibility for incentives through an abridged Budget:

<i>Sectoral Target</i>	CBD and Industrial
<i>Qualifying Criteria</i>	<ol style="list-style-type: none"><li>1. Investment to constitute new investment.</li><li>2. Investment to constitute Business Expansions.</li><li>3. Investment must be allocated in the manufacturing sector and/or enhances the value-added production capacity in the municipality (revenue collection).</li><li>4. Investment to constitute new and sustainable full time employment prospects (over 10 jobs).</li><li>5. Investment must be worth over R1 Million</li></ol>
<i>Incentives Offered By The Municipality</i>	<ol style="list-style-type: none"><li>1. Waiver of 80% on Building Plans Fees</li><li>2. 70% on Town Planning Application</li><li>3. Waiver of 80% on Business Licence Fees</li><li>4. 25% concession on electricity connection</li><li>5. Waiver of 25% on water and sanitations connection</li></ol>
