MAINTENANCE OF GRASS PITCH AT THE HARRY GWALA STADIUM, PIETERMARITZBURG

Tenders are hereby invited from suitably qualified and experienced Service Providers for the above works. Only tenderers who have experience in the maintenance of pitches in accordance with PSL Standards shall be eligible to submit tenders.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Wednesday, 27 August 2014**. A non - refundable tender fee in the amount **R401.28** (including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Briefing meeting will be held at **10h00 prompt on Tuesday**, **9 September 2014**, at the Harry Gwala Stadium, Princess Margaret Drive, Alexandra Park, Scottsville, Pietermaritzburg. Only one Tender Briefing meeting will be held. *Tenderers arriving at the meeting after the stipulated starting time will be disqualified.* An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed tenders endorsed on the envelope "**Contract No. SCM 29 of 14/15**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00**, on **Tuesday, 16 September 2014**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Ninety (90) days commencing from the closing date of tender.

<u>Tender Evaluation Criteria</u>: The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on the 90/10 Preferential Points System in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.

The Msunduzi Municipality does not bind itself to accept the lowest or any tender, and reserves the right to accept the whole or any part of a tender. Each tenderer will be informed of the tender result. The Msunduzi Municipality expects businesses within the Pietermaritzburg and Midlands Region to support its contract and BEE/SMME initiatives.
