**APPOINTMENT OF SPECIALIST CONSULTING ENGINEERS TO PROVIDE PROFESSIONAL CIVIL ENGINEERING SERVICES TO ADVISE ON A MAINTENANCE DESILTING EXERCISE FOR THE CAMPS DRIFT CANAL AND THE IMPLEMENTATION THEREOF**

The Msunduzi Municipality hereby invites tenders from Specialist Consulting Engineers to provide Professional Civil Engineering Services to advise on a maintenance desilting exercise for the Camps Drift Canal, Pietermaritzburg and the implementation thereof.

**A compulsory Tender Briefing Meeting** will be held prompt at **10h00 on Thursday, 30 April 2015**, in the **Exco Boardroom, 4<sup>th</sup> Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg**, from where all will travel in convoy to site. Only one Tender Briefing Meeting and Site Inspection Meeting will be held. An official will chair the meetings and answer any queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed tenders endorsed on the envelope with “**Contract No. SCM 94 of 14/15**” must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on Thursday, 07 May 2015**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Ninety (90) days commencing from the closing date of tender.

**Tender Adjudication/Evaluation Criteria:** The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 90/10 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.

The Msunduzi Municipality does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or any part of a tender. Each tenderer will be informed of the tender result.
