Tenderers shall be required to attend the compulsory Tender Briefing Meetings which will be held in the Exco Boardroom, 4th Floor, A S Chetty Building, 333 Church Street, Pietermaritzburg, 3201 on the dates and times mentioned above and thereafter travel in convoy to the various sites. ***No transport to the sites will be provided.*** Only one Tender Briefing Meeting will be held. An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. ***Tenderers who do not attend the above meeting will not be considered for appointment.***

Sealed tenders endorsed on the envelope with the relevant Contract No. must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than the closing dates and times mentioned above when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity period: Three (3) months commencing from the closing date of the tender.

Tender Adjudication/Evaluation Criteria: The tender shall be evaluated on the 90/10 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.

The Council does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or any part of a tender. Each Service Provider will be informed of the tender result. The Council expects businesses within the Pietermaritzburg and Midlands Region to support its contract and affirmative action programmes.
