CONDITIONS OF THE COVID 19 CRELIEF REBATE

1. Government Debtors on qualifying will be offered **100% discount on the rates interest and collection charges.**
2. Business Debtors on qualifying will be offered **50%** discount on the services arrear balance as at **31 March 2021** and **100%** discount on the rates interest.
3. Domestic / Household Debtors on qualifying will be offered **50%** discount on the services arrear balance as at **31 May 2021** and the **100%** discount on the rates interest.
4. Other Debtors on qualifying will be offered 50% discount on the services arrear balance as at **31 May 2021** and the **100%** discount on the rates interest.
5. Indigent Debtors, Public Benefit, Religious, Non- Profit Organisations on qualifying will be offered **50%** discount on the services arrear balance as at **30 June 2021** and the **100%** discount on the rates interest.
- 6 The above relief will be offered to qualifying customers subject to:
 - 6.1 All debt to be paid with **50%** deposit and the balance of the debt (less the discounted amounts) to be paid in three (3) equal instalments.
 - 6.2 Discounts to be applied to the accounts after the last instalment is paid and reflecting on the account or after the debt is settled (if paid in a single instalment).
 - 6.3 Debtors will complete the new service application form and the supply copies of identity document of the account holder
 - 6.4 The Municipality will conduct financial risk assessment to each applicant and where found that the customer risk profile has changed, the debtor will accept a reviewed their services deposit, minimum services deposit being an average of one month's municipal rates & services charges. The increased deposit requirement will be paid in three month's instalments after receiving the discount.
 - 6.4 All rates capital balances are paid in full and are not discounted.
 - 6.5 The Covid 19 Relief Offer shall be communicated to the applicant in writing and such offer will be valid 30 days after of the date of the offer letter.
7. No Discounts will be applied for properties being transferred/ sold / executed/ donated or for a period of six (6) months after receiving a discount
8. All payments related to the Covid19 Relief Discount offer must be made direct to the Msunduzi Municipality.
9. After receiving the discount, the debtor will have a Prepaid Electricity Meter installed at a cost to the debtor.
