Tenderers are hereby advised to take note of the following amendment to the Tender Notice as per invitation on Monday, 10<sup>th</sup> May 2021.

A compulsory **Tender Briefing Meeting** will be held on **Thursday, 27<sup>th</sup> May 2021**, in the **Finance Boardroom, 8<sup>th</sup> floor, Professor Nyembezi Building at 341 Church Street, Pietermaritzburg**, commencing promptly at **10h00**. *Tenderers arriving at the meeting after the stipulated starting time above will be disqualified. Further, all Tenderers attending the meeting must be in possession of a complete tender document failing which the Tenderer shall be disqualified. Tenderers producing only the Tender Briefing Certificate at the meeting will not be considered.* Only one representative per Company or Consortium will be allowed to attend the above meeting. No person will be allowed to represent more than one Company at the meeting.

It is compulsory for all interested tenderers to download a **Tender Registration Form** in order for the tender document to be emailed to the interested tenderer.
