### PUBLIC NOTICE CALLING FOR INSPECTION OF THE GENERAL VALUATION ROLL AND LODGING OF OBJECTIONS

Notice is hereby given in terms of Section 49 (1) (a) (i)/78(2) of the Local Government: Municipal Property Rates Amendments Act, 2014 (Act No. 29 of 2014), hereinafter referred to as the Act, that the valuation roll for the financial period **1 July 2024 – 30 June 2030** is open for public inspection at the Msunduzi Municipality municipal offices or at website [www.msunduzi.gov.za](http://www.msunduzi.gov.za) from the **9th April 2024** to the **15th June 2024**.

An invitation is hereby made in terms of section 49(l)(a)(ii) of the Act that any owner of a property or other person who so desires should lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from, the supplementary valuation roll within the above-mentioned period, from **09h00 to 15h00 (Mondays to Fridays)**.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the General Valuation Roll as such.
