# Zulu king's call for responsible parenting

he Zulu king, His Majesty, King Goodwill Zwelethini, has appealed to parents to take an interest in their children's education to help improve pass rates in schools.

He said while he was happy with improved matric results in KwaZulu –Natal, more needed to be done to deal with challenges, starting with the participation of parents.

"My message to parents is that they should not only care about their children's education when results are released but should be involved all the way," said the king.

He slammed their non-attendance of meetings and the election of School Governing Body members along friendship lines, and appealed that only worthy candidates be elected into such structures.

The king also cautioned teacher unions


against bringing turmoil in public schools, questioning whether their children attended such schools.

"Remove unruly and rotten elements among teachers, your unions and declare that anyone that disrupts education is an enemy of the people," said the king.

The opening of the legislature was attended by high profile figures including former president Jacob Zuma, former KZN premiers Ben Ngubane and Sbu Ndebele.

The king commended Zuma's decision to resign calling it a demonstration of bravery.

"I applaud Zuma's decision of February 14 and only a fool would not appreciate that what he did ensured that our country is not plunged into crisis as it sometimes happens in other African countries," said the king.

with improved matric results in KwaZulu –Natal, much more needed to be done to deal with challenges, starting with the participation of parents.



# It is important to pay for services rendered

s the administrative wing of the municipality, we know and appreciate that in order to be a financially viable organisation, we need to have an efficient revenue collection mechanism.

This is why we are now strengthening our revenue collection - that includes an audit of our customers - both those who pay and those defaulting.

For the record, the Department of Co-Operative Governance and Traditional Affairs revealed that municipalities in KZN are owed R13 billion by customers who vary from private businesses to government.

What was more startling though, was the revelation, that the total owed by households was a staggering R7,1 billion.

MEC Nomusa Dube Ncube was at pains to admit that if this challenge was not attended to, municipalities faced the prospect of collapsing.

She said the reality of customers not honouring their debt was something that had to be dealt with immediately.

As an illustration that we are serious about getting what is owed to the municipality, we are conducting regular checks of our debtor's book, identifying defaulting customers and disconnecting them until they have repaid the municipality.

It may not be a popular decision but it is one that will result in a positive situation for Pietermaritzburg. It is about ensuring that the municipality is in a financially viable state.

Having money in our accounts means that the municipality would be able to pay its employees each month, and it enables the municipality to rollout further services in parts that have not been reached yet. Customers may not know this but the municipality does not undertake major projects whether they involve electricity or water provision from nothing.

The Msunduzi municipality, like any other organisation goes to banks and other funding establishments to borrow money so that such projects can be rolled out. When such projects are completed, we are expected to pay back the money owed to our funders – and that is why it is important for our customers to pay the municipality for services



rendered. It makes it easier for the municipality to improve the level of service delivery for the future and failure cripples the organisation.

The city's Operation Qoqa Imali is targeting residents, government departments as well as businesses who are not paying for services received.

So, our appeal, as the administrative wing of the Msunduzi Municipality is for every customer to play their role in making ours a financially viable municipality and a thriving city full of opportunities where everyone concerned gets the best services.

## Premier's warning to department heads

ifestyle audits will soon be rolled out for senior government officials, especially in the Supply Chain Management sections, in a bid to stamp out fraud and corruption in government.

This was the undertaking made by KwaZulu-Natal Premier Willies Mchunu when he delivered the State of the Province Address at the Royal Showgrounds, Pietermaritzburg on Wednesday. He said government was concerned about episodes of fraud and corruption in departments where money, meant to serve people, was siphoned by individuals for

personal gain, promising tougher sanction in future.

"We will apply a zero tolerance approach in dealing with those who are found guilty of these transgressions. We will be starting lifestyle audits of officials in high risk positions and we are starting with our supply management units," said Mchunu. The string of adverse audit opinions, the premier continued, reflected badly on government's ambitions to champion good governance and was eroding public confidence on government. As a response to this, all Heads of Departments and Chief Financial Officers would be held accountable for

adverse audits. While adding that the senior officials would be punished, he did not indicate the kind of punishment awaiting responsible officials. He said government would instil a culture where integrity at the core of its everyday activity, and committed his government to a public-private coalition dedicated to combating fraud and corruption.

Aside from this Mchunu committed his government to among other things:

- Strengthening municipalities
- Ensuring safer communities strengthening interaction between the police and communities.

- Rolling out infrastructure, especially in rural areas ensuring access to water and electricity
- Providing capacity to schools in a bid to improve education and pass rates. Mchunu appealed to communities to assist government especially in the fight against crime by reporting criminals

to the police as opposed to harbouring them. In addition to this he also urged residents to adopt healthy lifestyles so that the public healthcare system is not drained by people suffering from diseases that could have been prevented.

## Municipality to tackle illegal dumping

he Msunduzi Municipality's waste management efforts have received a boost after an agreement reached with the district municipality. This was revealed in a report tabled before a full council meeting held on January 31 at Council Chambers.

"The municipality is currently faced with a problem of ever escalating dirt due to illegal dumping, littering, unlawful and uncontrolled business activities," read the report that also cited the municipality's structural and systematic inability to deal

with waste management effectively; as well as limited municipal resources.

The assistance will come in the form of suitably skilled human resources to assist in building and strengthening capacity within the municipality's waste management unit. Community Services committee chairperson Sphamandla Khumalo said the move would help in ensuring that the municipality succeeded in making the city clean.

"There is no doubt that we have a serious challenge and that is why the leadership,

including Exco members, have been at the forefront to make the city clean. Any assistance to beef up capacity for the city to deal with the challenge is always welcome," said Khumalo.

Since last year, the municipality has undertaken a range of initiatives to keep the city clean galvanising local businesses, households and citizens to be part of the movement to ensure that the municipality is clean.

## Move to monitor air pollution

The Msunduzi Executive Committee (Exco) members have approved a call for air quality monitors to be installed in Edendale and Northdale. This follows the tabling of the ambient air quality report at the Oribi Airport that regularly monitors air quality in the

The assessment is in line with national regulations to determine whether the city follows the National **Environment Management Act that** focuses on, among other things, the quality of air both in residential and industrial areas.

"Residents, in accordance to the Constitution, are entitled to a healthy environment that is not harmful to

their health or well-being," read the report presented to Exco members.

Currently there are two air quality monitors - one at the airport and the other in the CBD.

City Entities and Sustainable Development committee chairperson, councillor Eunice Zondi emphasised the need for monitors to be installed in all strategic parts of the municipal

"We need to fast track the process of installing such facilities both in Edendale and Northdale because a significant portion of the population is found in these areas," said Zondi.

## City energy plans on track



The City's multi-million rand electricity project that includes building new power stations and substations is progressing as planned with a number of sub-stations operating better after undergoing upgrades. Infrastructure Services committee chairperson Thobani Zuma said they were looking forward to the completion of the stations.

"It is important that city residents receive power that is uninterrupted so they can go about their lives without any unnecessary hiccups," said Zuma.

The upgrade of the electricity infrastructure forms part of the Electricity Network Development Plan that was adopted by Council during the 2012/13 financial year. After this, Council approved the R250 million loan from the Development Bank of Southern Africa to address ageing electricity infrastructure. Some of the projects that were funded by the loan include:

- Upgrade of the 132/11kV Northdale Substation where two new 40 MVA 132/11kV Power Transformers with the new 11kV switchboard were installed.
- Upgrade of the 132/11kV Prince Alfred Substation where a 132 Gas Insulated Switchgear was installed.
- Upgrade of the 132/33/11kV Retief Substation (phase 1) which involves the installation of a 40MVA 132/11kVPower Transformer.
- Establishment of a 132/kV City Grid (phase 1) which involves the installation of new 132kV circuits between Retief, Archbell and Pine Street Substations into the Prince Alfred Substation.

The provision of stable and reliable power is seen as one of the crucial elements for the city as it seeks to attract more investment from companies that want to do business in the city. An increase in investment provides a chance for city residents to get much needed jobs.

#### **Birds of Prey Sanctuary**

situated on 60 hectares of scenic valley bushveld, within easy access of both Durban and Pietermaritzburg, the African Bird of Prey Sanctuary is a safehaven to the widest selection of

indigenous raptors in Southern Africa.

The African Bird of Prey Sanctuary is a working facility dedicated to the conservation of indigenous raptors and is base to on-going research, breeding and rehabilitation projects for birds of prey. The majority of these projects run 'behind the scenes' to ensure that the integrity of the wild birds is not compromised and that a high release success rate is achieved. The sanctuary is also, however, home to a wide selection of captive-bred or 'non-releasable rehabilitation' birds of prey. These raptors can be viewed in their 'micro-environment' enclosures by anyone who wishes to visit and learn about South Africa's magnificent aerial predators.

The Centre also provides education about birds of prey, and the threats that they face which is an important part of raptor conservation. One of the primary roles of the African Bird of Prey Sanctuary is to introduce raptors, in all their magnificence, to the general public. To facilitate this, a specially trained group of raptors are flown in daily flight displays. These demonstrations allow the raptors themselves to become both teachers and ambassadors for their wild counterparts, so that members of the public can

experience these normally rare and elusive birds first hand.

Facilities at the centre include a gallery where you will find unique pieces of African art. There are crafts if you are just looking for a memento and Kestrel Café providing great view of the surrounding area and something to eat. Visiting when there is a flying display offers a special experience. Some of these birds come so close to you that you can see the detail of every feather and feel the breeze against your skin as they fly past.

It is hoped that people, both young and old, and from all walks of life come away with an appreciation of South Africa's fantastic diversity of raptor after seeing the birds first-hand.




