## Council vows to help improve Audit Reports

Municipal councillors have given a firm commitment to ensure achieving a better future audit report.

This follows after the municipality recently received a disclaimer from the Auditor-General.

At a recent sitting, councillors said city officials must be given a chance to implement a turn-around plan in motion to help the municipality improve its position.

Councillor Sibusiso Mtshali expressed disappointment with the report and appealed to the management to provide reports more timeously to enable councillors to discharge their oversight duties.

Another councillor Sandile Ngubane echoed the sentiments of disappointment with the audit report.

“We acknowledge that this report is bad and reflects badly to everyone concerned, but let us give

management a chance to present their plan and work on finding the solution. The plan that will be tabled at the next council sitting in February is expected to provide, in great detail, how the municipality will spend money efficiently and ensure that service delivery objectives are met.

Msunduzi Mayor Themba Njilo appealed to all councillors to assist in making the City a better place by scrutinising documents when attending meetings so that problems are detected at an early stage. “It is up to all of us to make the Msunduzi Municipality the best in the province and it is in line with the commitments we made when we assumed office in 2016,” said Njilo. He added that as the provincial capital Msunduzi is expected to lead by example both in the managing of finances and service delivery as this would help in attracting investments in the city.

## IRPTN project on track

Workers continue with construction in Moses Mabhidia Road that forms part of the Intergrated Rapid Public Transport Network (IRPTN). The project is funded by the Department of Transport and once complete will be able to accommodate large volumes of traffic from Imbali, Edendale, Vulindlela and surrounding areas. Recently Msunduzi councillors visited the site to check progress on the construction as part of their oversight duties and expressed their satisfaction at the pace of the construction. The IRPTN project is one of a number of infrastructure projects under the Msunduzi Municipality.

### Warning to drivers



MSUNDUZI Municipality Traffic department has appealed to drivers to report traffic police officers who ask for bribes. The call comes in the wake of a recent arrest of a man who had been impersonating a traffic officer,

and taking bribes. According to Acting Traffic Inspector Bheki Zondi people must be careful when they come across individuals who want bribes and should insist that officers produce positive identification including

an appointment card. Community Services Committee Chairperson Sphamandla Khumalo stressed that communities needed to be vigilant against all forms of criminal activity and report them to nearby authorities.

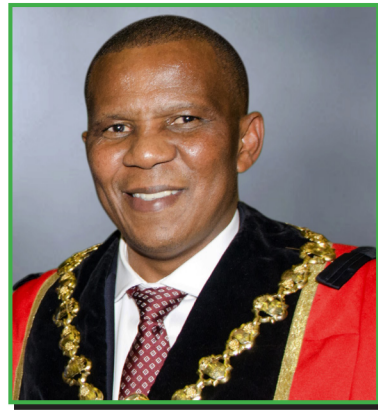
### More high mast lights

More funds have been put aside for the rollout of high mast lights in all parts of the municipality. This is contained in a report tabled at a recent meeting of the Infrastructure Development Committee where it was revealed that 133 mast lights have been installed to date. The lights assist with road safety and better traffic flow and helps in deterring crime and vandalism. # City has turn-around strategy in place



As the administrative wing of the Msunduzi Municipality we take full responsibility for the report from the Auditor General (AG) for the 2016/2017 financial year. We have noted this report with concern and wish to place on record that despite this setback, the municipality is still financially viable. This position has not affected the Municipality's going concern. It is still in a position to meet all its financial obligations and service delivery imperatives as approved in the IDP.

We are aware of the challenges before us as the Msunduzi Municipality is the Capital city of KwaZulu Natal and that means we should lead by example. The feeling among officials, especially at senior level, echoes the sentiment that we have let our ratepayers down. As the City Manager and head of the administration, my commitment is to see to it that all our staff does their work diligently. The blatant incompetence shown by our staff will not be allowed to continue and as a team, we will be addressing issues raised by the AG to restore

the confidence of our ratepayers.

The Municipality has developed a turn-around strategy that will address the audit outcomes. We will endeavour to make certain that all systems, controls, and procedures are overhauled to ensure that the Municipality is operating optimally.

To this end, the following measures have been developed for urgent implementation:

- Internal Controls

The Municipality has appointed an audit firm to assist in the implementation of the turnaround strategy and action plan.

- Governance

All governance structures, including the Internal Audit Unit, Municipal Public Account's Committee (MPAC) and Full Council will be capacitated to ensure development and monitoring of risk based analysis that will address the deficiencies in the system of internal controls. We will be providing training to staff to capacitate them where it is necessary.

There will be a major focus on the filling of

key and critical positions.

- Oversight

Training our Councillors on issues of finances so that they can play an active oversight role.

- Leadership

Consequence management will be applied where necessary. The Leadership will be cracking the whip and showing no mercy in ensuring compliance. We are appealing with the workforce and the community of the Msunduzi Municipality to remain calm. The Municipality is still in capable hands to deliver on its mandate, and let us continue to work together in achieving our vision of a safe and vibrant city, in which to live, learn, raise a family, work play and do business. We want to see to it that as of now the municipality moves in an upward trajectory and lives up to its billing as the capital city that is second to none.

# Progress in township development



City Entities and Sustainable Development Chairperson Eunice Zondi has expressed satisfaction at the pace of construction for the Imbali Industrial Hub. The multi-million rand project is expected to breathe life in Imbali as it will provide a range of services to local businesses and forms part of government's township economy. The entrance that was targeted for completion in January is finished while construction inside continues. Zondi said the committee was pleased with progress and was positive that the project would finish within the intended period.

## SARS to investigate religious institutions

The South African Revenue Service (SARS) is to work with religious institutions to investigate tax non-compliance, it said recently.

"SARS will engage religious institutions with the intention of investigating possible tax non-compliance in this sector. The decision follows SARS' own preliminary investigation, its meeting with the CRL Rights Commission and general reports suggesting that certain religious organisations and leaders are not in compliance with tax laws, and may be enriching themselves at the expense of tax compliance and their altruistic and philanthropic purpose," said the revenue service.

In its statement, the revenue service acknowledged that a number of religious organisations are indeed complying with their tax obligations.

Religious institutions may apply to SARS to be exempted from the payment of Income Tax and certain other taxes in terms of section 10(1) (cN) of the Income Tax Act, 1962, read together with the provisions of section 30 of the Income Tax Act, 1962. Once such tax exemption status is granted, there are a number of specific criteria that have to be complied with, including but not limited to:

-Conducting activities in a non-profit manner with an altruistic or philanthropic

intent;

-No such activity is intended to directly or indirectly promote economic self-interest of any person other than by way of reasonable remuneration paid for services rendered;

-Religious institutions are prohibited from directly or indirectly distributing funds to any person other than in performing their religious activity.

"SARS is also concerned that proper taxes on trading activities that are unrelated to religious activities as well as Pay As You Earn (PAYE) on remuneration and other benefits are not being paid in terms of legislation. Over and above, SARS has further found a number of religious institutions

issuing tax deductible receipts in terms of section 18A of the Income Tax Act, 1962, for donations towards religious activities. This is not permitted in terms of the Income Tax Act, 1962."

SARS further encouraged these entities to use its Voluntary Disclosure Programme to regulate their taxes.

"SARS will be reaching out to the CRL Rights Commission and faith community to raise awareness about the relevant tax obligations of religious institutions where applicable."

## Minimum wage to be reviewed annually

The national minimum wage will be reviewed on May 1 of each year, in line with government's aim of alleviating poverty in the labour market.

"In the review of [the national minimum wage], the commission that advises the Minister [of Labour] has to take a number of factors into consideration such as inflation, the cost of living, wage levels, wage differentials, productivity, the ability of business to carry on successfully as well as the impact on Small Medium and Micro-sized Enterprises (SMMEs) and employment," Director: Employment Standards at the Department of Labour Stephen Rathai said.

He said the review process should also promote medium-term targets to reduce wage differentials and alleviation of poverty.

"The regulation will include the procedure for exemption, the obligation on employer to consult with the employees or their trade unions and the criteria for evaluating exemptions," Rathai said.

The briefing sessions are being held around the country and started on 9 November 2017. They target all sectors of the economy.

Briefing sessions have been held in Johannesburg, Pretoria, Cape Town, George, Pietermaritzburg, Richards Bay, Durban, Tzaneen and Polokwane. The national minimum wage is scheduled for implementation from 1 May 2018.

The agreed national minimum wage at National Economic Development and Labour Council (NEDLAC) is pegged at R20 an hour for major sectors, with the exception of sectors such as farm workers and domestic workers.

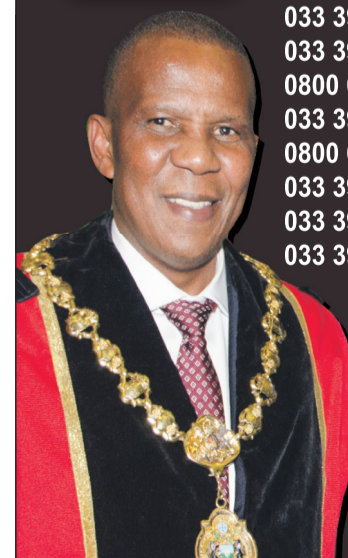

## 2018 Comrades Marathon Route Changes

The official distance of the 2018 Comrades Marathon as well as changes to the route have been confirmed by the Comrades Marathon Association (CMA). CMA Race Director, Rowyn James says, "The officially measured and certified distance for this year's Down Run is 90,184km."

The 2018 Comrades Down Run will be slightly longer than the previous Down Run route. The 2016 route was 89,208km."

James has advised that some changes will be effected from

the Start at the Pietermaritzburg City Hall. He says, "On race day, our runners will start their epic Down Run journey at the City Hall, running down Chief Albert Luthuli Street, heading east. From there they will continue along Alan Paton Avenue and then contraflow onto the N3 national freeway. From there, they will glide off right onto the Market Road on ramp and then left onto the slip road to CB Downes Road and then follow the traditional Comrades route towards Polly Shortts and onwards to Durban."

James continues, "Regarding

the route into Durban, athletes will follow the N3 under the Tollgate Bridge and then take the new fly-over into David Webster Street which becomes Bram Fischer Road. From there, our runners will turn left into Samora Machel Road which then becomes Masabalala Yengwa Avenue."

James concludes, "Runners will then run contraflow in Masabalala Yengwa Avenue and cross to the north bound lane at Battery Beach Road. They will then take the pathway to the left between the bollards, pass the Virgin Active Gym and turn left

into the tunnel before Nino's and onto the field to the Finish Line at the Moses Mabhida Stadium."

As per the Safety at Sports and Recreational Events Act 2010, James has also confirmed that the new finish at Moses Mabhida Stadium aligns with the requirements of the Events Act which necessitated the move to this iconic Durban landmark."

James has thanked the eThekweni Metro Police and Msunduzi Traffic Police for providing escorts to ensure the safety of the route course measurer, saying, "We are

working closely with all traffic and law enforcement officials to ensure the safety and integrity of the event."

James adds, "Working with the officials at the Moses Mabhida Stadium has been a pleasure. We look forward to ensuring a great race day for both our runners and spectators on Sunday, 10 June 2018."
