UMsunduzi ulekelela umatikuletshe

UKHUVETHE luphazamise izinhlelo ebezihleliwe kulo nyaka nokuthi zizokwenzeka ngasiphi isikhathi, ezinye kugcine kungasazeki ukuthi ngabe ziyaqhubeka yini.

Ezinye zalezo zinhlelo ilapho kulindeleke ukuba abafundi bakamatikuletshe bafake izicelo zokuyofundela imikhakha abayikhetheyo ezikhungweni zemfundo ephakeme. IMeya yaseMsunduzi uMhlonishwa uMzimkhulu Thebolla ithumele ihhovisi layo ezintekeni elimeme izinhlelo ezizokwenzeka ukuba ziyolekelele abafundi.

Kuqalwe lolu hlelo ngokuvakashelwa kwezikole iBongodunga High School neGeorgetown yizikhulumi ezizokwenzeka emanyuvesi ezobuchwephe iDurban University of Technology (DUT) neMangosuthu university of Technology (MUT), isikhulumi esiqhamuka kuMwelase Foundation nenkameli iMondi.

UMnu uLucky Mbatha obemele ihhovisi leMeya wazise abafundi

ukuthi lezi zikole ziphakathi kwezinye eziseduze kwenhliziyo yeMeya. “IBongodunga iyo kuphela ebeyimele isifunda uMgungundlovu kungxoxompikiswano ebibanjwe ebuxhakaxhakeni bezokuxhumana kuphalamende leSishayamthetho. Umfundi obemele lesi sifunda nguSibahle Mndima. Esikuphathele abafundi isikhali esinzima kunazo zonke okuwulwazi,” kusho uMbatha.

UMnu uLungelo Sithole oluleka ngokuqoka imikhakha kofisa ukuqhuba izifundo zemfundo ephakeme uthe: “Sicela abafundi basebenzise izinhlelo ezibekwe uHulumeni, abasebenzise ihhovisi leYouth Centre eliku-19 Galloway Lane ukwelulekwa ngemikhakha abangayikhethe.”

Leli hhovisi lelekelela ukuthuthukiswa kwezemidlalo, kwamabhizinisi neminye imikhakha. Unxuse abafundi ukuba bahlale belungile njengoba ubhubhane ukhuvethe lukhombisile ukuthi ikusasa alaziwa.

Weluleke abafundi ngokuthi bangawabukeli phansi amakolishi bangamaTechnical Vocational Education and Training (TVet).

oqhamuka eMUT wazise abafundi ukuthi le nyuvesi inezigaba zemfundo (faculty) okungesobunjinnyela, iMovement Science eNatural Science wabe esebachazela ngezifundo okufanele bazithathe ukuze bakwazi ukungena kulezi zigaba. Kwesobunjinnyela kumele umfundi abe neMathematics, iPhysical Sciences ne-English.

Kumele abe nemiphumela engaphezu kwama-50 isifundo ngasinye namaphuzu angama-30.

KwaNatural Sciences kudingeka iLife Sciences noma iPhysical Sciences, iMathematics noma iMaths Literacy kanye ne-English. Kudingeka amaphuzu angama-28.

Weluleke abafundi ukuba bangabheki la maphuzu amancane ngoba lo mkhakha uthatha abafundi abangama-60, okusho ukuthi baqoka labo abanaphezulu.

kwaMovement Science badinga amaphoyinti angama-25, izifundo okumele umfundi abe nazo yi-Accounting, iMaths kanye ne-English. Ube eseluleka izingane ukuba ngenkathi zisafaka isicelo zibhale ukuthi zizowungela umfundaze iNational Student Financial Aid Scheme (NFSAS).

“Kuqala uNFSAS ubuyisikweletu manje sekuwumfundaze njengoba kunokhuvethe ningakwazi ukuthi nivakashele izikhungo sicela nisebenzise ubuchwepheshe ngokungena kugoogle ubheke uMUT Schools.”

UMnu uMichael Zulu oqhamuka eDUT wazise abafundi ukuthi lesi sikole samukela abafundi abafake izicelo kwaCentral Application Office (CAO) kuphela.

Unxuse abafundi ukuthi bathole ukwalulekwa ngokufakwa kwezicelo. “Iphutha elijwayele ukwenziwa abafundi ukungalandelanisi ngendlela ezisemuzwini yakhe.”

Okunye engikucela kubafundi ukuthi bakhethe izifundo okuthiwa zinqabile lapha eNingizimu Afrika kepha okumqoka ukuthi kube izifundo ozozithanda. Lapha eNingizimu Afrika ili-100 uhlobo lwemisebenzi okuthiwa iyashoda.”

Okugcizelwe uZulu ukuthi akuzona izifundo zobusayensi kuphela ezishodayo kepha nezokupheka, kungekona ukuthi abantu bakuleli bengakwazi ukupheka kepha iziqu abanganazo ingakho sekulandwa abasemazweni

angaphandle.

Okunye akugcizelilele ukuthi abafundi bafake izicelo zabo kuNFSAS ngoba uHulumeni uhlinzeka ngayo yonke into okomfundi ukuthi abafundi abe nemiphumela emihle.

UNks uNomfundo Dubazane oqhamuka eMwelase Foundation uthe njengengxenywe yokugqaguzela abafundi ukuthi bafake izicelo zokwenzela izifundo zabo bazokhokhela izingane ezine.

UNks uNangomso Qqejana naye uthe uzokhokhela izingane ezine. Laba bafundi abahlabane ngalolu sizo bebhendula imibuzo esidlangalaleni, othole kahle nguye ozokhokhelwa.

Ukuvalwa kwezicelo zoxhaso lwakwaNFSAS kuvalwa mhla zingama-30 kuLwezi kophezulu. Kulo nyaka iTvet ikhishiwe kuCAO kwasala iNyuvesi yaKwaZulu-Natal, iNyuvesi yasoNgoye (Zululand), IMUT neDUT.

Lama nyuvesi amukela abafundi abafake izicelo kwaCAO kuphela, awasabamukeli abazifikela mathupha. I-UNISA kanye namaTvet ibona kuphela abanendlela ehlukile yokufaka izicelo.

UKULAWULWA KWEMFUCUZA

UMsunduzi ulungisa indawo yemfucuza

nguSiyethaba Mhlongo

SELOKHU kuqubuke umlilo ezinyangeni ezedlule endaweni yokulahlala imfucuza eMsunduzi izinhlaka zikaHulumeni ezibhekelele le ndawo enkulukazi yokulahlala udoti bezisebenza zingaphumuli ukuthola izixazululo kungabekeki impilo yezakhamuzi zaseMsunduzi engcupheni.

ISikhulu Esiphezulu sophiko lwakwaWaste kulo Mkhandlu, uMnu uWilson Mhlongo, sigeqe amagula sisho ngezinhlelo uMsunduzi neminye iminyango kaHulumeni abanazo ukuthuthukisa le ndawo.

UMhlongo uthe emva komlilo owaqubuka kule ndawo kusungulwe ikomiti elihlangana nsuku zonke ukuhlonza izingqinamba ezihlasele ilandfill. UMnyango Wezokubusa Ngokubambisana Nezindaba ZoMdabu yiwo obuhola leli komiti. UMhlongo uthi lo Mnyango bewubalekelela ukuhlaziya nokuhlonza izinkinga ezizumongo kule ndawo, incwadi yokungahlangabezani nemigomo yelandfill eyayikhishwa ngaphansi kweSigaba sama-31(L) ebisikhuluma ngezikhala ezihlonzwe uMnyango, kulandela isigameko somlilo owaqubuka kuqala unyaka ngoNhlolanja.

“Into ehlonzwe njengeninga yokuqala imishini ebizwa ngeYellow Plant, okuyinsizakusebenza emqoka ekusebenzeni kwansuku zonke kwelandfill. Okunye okwahlonzwa njengeninga ukulawulwa kwelandfill nokuthi kushutshekela kanjani phambili,” kusho yena.

Uthe njengengxenywe yesixazululo, balandele lokho okuwumyalelo woMnyango, obekuyizinkinga zokulawulwa kwelandfill. Okokuqala bekuwukuhlonza uhlobo lwemfucuza engena khona ukuze kuqinisekisewe

ukuthi abalahlayo abaphethe yini imfucuza eyingozi. Okwesibili ukuthi izisebenzi zilawule inani lezimoto ezingena kuleya ndawo, okwesithathu ukuthi kube nezisebenzi eziyalelayo ukuthi ikhasimende kumele lilahle kuphi. UMhlongo uthi zonke lezi zinkinga seziwumlando njengoba sebevuselela neweighbridge okungenye yezinto ekwazi ukuhlonza imfucuza engena kule ndawo.

Uthe enye yezinkinga eyayihlonziwe kwakuwukuthuthwa kwenhlabathi ezogqiba le mfucuza ngoba uma igqitshiwe ayokheleki ngomlilo futhi akubikho izilwane ezinjengamagundane. “Iloko esesiqalile ukukwenza, ukuqala okugwalisa lezi zindawo ezinesikhala sesiqalile futhi ukuqinisekisa ukuthi indawo iyaqonda yonke futhi nokuhamba kwamanzi kuzokwazi ukulawuleka kahle (drainage system) ngoba

kumele siqinisekise ukuthi amanzi azobe echithwa ilandfill awayi emfuleni uMsunduzi kepha aya endaweni eyakhelwe lokho khona kulandfill,” kusho yena.

Uqhube wathi ngokwezempilo kunebanga elibekiwe okungamele abantu bakhe onqenqemeni lwelandfill. “Lokhu kukhuluma ngokuthi kungani uMasipala ulwisana kanje nemikhukhu eyakhe kule ndawo. Lokhu bekwenziwa ngenxa yokuhlenga izimpilo zabantu,” usho kanje.

UMhlongo uthe enye inkinga abebhekene nayo eyokusetsenziswa kabusha kwemfucuza (recycling) ephinda ikhulume nabantu abenza lo msebenzi ukuziphilisa ngelandfill.

“Bekungekhona ukuthi bacosha imfucuza kuphela kepha bekunobugebengu obuningi obebuqhubeka ngenkathi becosha.

Kudingeke ukuthi siqhamuke namaqhingasu azokhuluma ngokuncishiswa kwemfucuza elahlwayo elandfill.”

Uthe okudingeke ukuba bakwenze ukuba nohlu labantu abacosha imfucuza lapha nokuqinisekisa ukuthi bakwenza lapho kuvumeleke khona hhayi lapho kusetshenzwa khona ngoba ngokomthetho kumele kube nabantu abaqeqeshelwe ukusebenza kuyo ngenxa yobungozi bemishini.

“Abantu abacosha imfucuza basakhona, uMasipala usahlonza indawo lapho abazosebenza khona. Manje sebeyalawuleka, uma kushaya ihora lesine ntambama kukhuphuka abaqaphi basebenzise imibhobho ukubayalela ukuba baphume, futhi bayalalela,” kusho uMhlongo.

UMhlongo uthe uMnyango Wezokuthuthukiswa Komnotho uyabahola ekutheni bazolekeleleka kanjani laba bantu ukuze basebenze ngendlela efanele nephephile futhi kungabi bikho ozolahlekelwa ngokuthize. Uthe ukuba khona kwabantu abacosha imfucuza kuyawuzuzisa noMasipala ekutheni isikhathi selandfill seluleke ngoba udoti uzobe ungalahlwa wonke.

“Laba abacosha imfucuza bazobe beklala indima kuGDP njengoba bezobe bebhaliwe ngokusemthethweni,” kusho yena.

Odabeni lokushoda kwemishini, uthe uMasipala sewuqalile uhlelo lokuyithenga ukugwema izigameko ezifana nesenzekile ngaphansi kweSigaba sema-30. “Esiphezu kwakho njengamanje ukuvala igebe phakathi kwezisebenzi ezingenaso isipiliyoni sokusebenza elandfill bese zithola ukuqeqeshwa ukuze zifike kulelo zinga. Sesisebenzisana noMnyango Wezasekhaya ukususa izakhiwo ezakheke onqenqemeni ngoba kunabantu okungasibo bakuleli abakhe kuleya ndawo kanjalo namaphoyisa ukuqapha noma ngabe isiphi isimo esenzekayo.”

UKULAWULWA KWEMFUCUZA

UMsunduzi namaqhingasu ngemfucuza

UKULAWULWA kwemfucuza kwehlukene. Emva kwesikhathi eside uphiko lwakwaWaste lungenayo imeneja ngokusemthethweni, ngenyanga kaMbasu uMasipala uqhamuke nesixazululo yaqasha uNks uNokubonga Kunene (osesithombeni) njengeMeneja yakwaDomestic Waste. Umsebenzi wakhe ubheka ukuqoqwa kwemfucuza eMsunduzi umuzi ngomuzi, ukushanelwa kwemigwaqo, ukuqoqwa kwemfucuza ezindaweni zamabhezini, ukuhlanzwa kwalapho kulahlwa khona ngokungemvume nokuhlanzwa kwezindlu zangasese zomphakathi.

UNks uKunene uthi akuthole kushoda kule ndawo selokhu eqalile ngoMbasu indlela okulawulwa ngayo izimoto. “Lolu phiko belungakwazi ukuxhumana kahle nalabo ababhekelele izimoto, njengokubika ngezinguzi ababe nazo, ukuthi yenze kuphi kanjani, obekuholela ekutheni lungatholakali usizo njengokuthi kukhokhe imishwalense.”

Uthi okunye akutholile ukuthi izisebenzi bezingayinakekeli impahla nezinsizakusebenza njengamaloli abefa njalo. “Njengengxenywe yesixazululo sesakhe ubudlelwane nalabo abakhanda izimoto okungangokuba noma ngabe kwenzakalani emotweni sixhumana nabo ukuze ukusebenza kusheshe futhi sikwazi ukulekelela umphakathi. Nabo sebeyashesha uma

benza umsebenzi ngoba umsebenzi usuthinta nabaholi ngaphambilini babengekho,” usho kanje.

Uqhube wathi ezinye izingqinamba lolu phiko obelubhekene nazo ukubika obekungenzeki. “Manje sibona kuthuthuka, izinduna sezizakwazi ukusho ukuthi izisebenzi eziziqaphile zikuphi futhi zenzani galeso sikhathi. Ngalokho nendlela esiqoqa ngayo imfucuza ithuthukile futhi sesiyilanda ngesikhathi.”

Uthe lezi zinguquko ezintsha zizoqeda izindawo okulahlwa kuzo imfucuza ngokungemvumo ngoba nezisebenzi sezizakwazi ukuzilawula, sezibuyela lapho ezaziqashwe khona. Uveze ukuthi akutholile ukuthi izisebenzi bezizisukela ziye kwenye indawo ngoba zibona engathi kunemihlomulo engcono kunalapho ebeziqashwe khona njengokuthi oqoqa imfucuza aye kwabashanela umgwaqo ngoba ebona engathi umsebenzi wabo ulula.

“Kusukela manje sicela izakhamuzi zikhuphe imfucuza ngezinsuku ezihlonziwe ngoba iphutha ezike zilenze ukuthi uma

zibona izisebenzi zikaMasipala zingafiki bese ziwubuyisela ezindlini. Kuyenzeka uthole ukuthi sinenkinga yezimoto mhlawumbe zifile okuphoqa ukuthi silinde ebiphumile kushintshwane ngayo okudala ukubambezeleka. Ngendlela esibebenza ngayo manje alupheli usuku ingalandwanga imfucuza lapho kumele ithathwe khona ngoba asifuni ukusalela emuva ngomsebenzi, ingakho uma ingaqoqwa emini ilandwa nangobusuku,” kusho yena.

Unxuse izakhamuzi ukuthi imfucuza yasengadini bayangixubi neyasendlini. UMsunduzi unezindawo eziyisi-7 zokulahlala imfucuza yasengadini.

Le mfucuza izakhamuzi zingayilahlala zonke izinsuku ngoba lezi zindawo zihlala zivuliwe kanti aziyamukeli eyasendlini. Uqhube wathi kuwumsebenzi wezakhamuzi

ukuhambisa izitini nokhonkolo okusala uma kade kwakhiwa elandfill site (rubble waste).

Uthe edolobheni baqhamuke nendlela entsha yokusebenza ngenxa yesibalo sabantu esiphezulu abalisebenzisayo kanti abakutholile ukuthi izakhamuzi zilahlala noma ikuphi. Bagcine bunoma ukuba kusetshenzwe ngokushintshana kubekhona abangena emini nabasebusuku ukuze kugcinwe idolobha lihlanzekile. “Esisanda kukuthola okungenza idolobha lethu linganakeki ukuthi selihlanzekile ukuthi lingadwetshwa phansi, ngakho sibone kumqoka ukuthi sisebenzisane namanye ma-unit ukuze kubonakale okwenzekayo, siphinde sabona igebe lokuthi sibuyise uhlelo olwalukhona lokuthshala eziqhingini ukuze kube kubukeke kahle,” kusho yena.

Uthe kulesi sabelomali bazothenga imigqomo engaphezu kwama-200. Uqhube wathi bavuse uphiko lwamapeace officers wathi uma amalungu omphakathi ubona kunomuntu ongenzi kahle ambike bona bazolulandelela udaba baphinde bashushise.

“Sicela izakhamuzi zikhuphe imfucuza ngesikhathi okuyi hora lesi-7 ekuseni. Uma kulihlodi baqhubeke bawukhiphe noma engabe uKhisimusi uzolandwa. Sicela ukuxolisa sisazoqhubeka sibavuse ngoba izakhamuzi zikhala ngokuthi zishiywe imoto kadoti. Izisebenzi zethu sezizigqudelelele azisadluli ngoba ungenkathi udoti emaqweni sezibavusa abantu.”



Libuyile ikomiti lezixazululo eMsunduzi

NGENXA yokhuvethe imihlangano ethatha isikhathi eside ayivumelekile futhi kunesibalo sabantu abangama-50 okumele bahlangane uma indawo ivuleke ngokwanele. Khona kunokhuvethe kepha ukhlinzekwa ngezidingo komphakathi kuwu mklamu kaHulumeni. UMsunduzi uyayilandela imigomo yokhuvethe njengokugcina kwa kwebanga phakathi kwabantu, ukufaka isifonyo osekuyimpoqo eNingizimu Afrika kanjalo nokuhlamba izandla ngamanzi anensipho noma ngesibulalimaciwane.

Imihlangano eMsunduzi seyibanjwa ngezobuchwepheshe kepha kunemihlangano ehlanganisa izisebenzi zikaHulumeni kanye nabaholi bamalungu omphakathi. Mhla zili-18 kuNcwaba ikomiti iLocal Task Team for Operation Sukuma Sakhe (LTT) lihlangane okokuqala selokhu kwaba nemvalelwakhaya. Leli komiti lakhiwa iminyango kaHulumeni eyahlukene. Okusuke kulindelekile kule minyango imibiko yokuthi yini eyenzela umphakathi nezingqinamba ehlangabezana nazo.

Leli komiti lihlanganele ehholo lomphakathi kwaGezubuso kudingidwa izinkinga eziphathelele noVulindlela. UMnu uMusa Kunene onguSihlalo waleli komiti uyisisebenzi soMsunduzi ngaphansi kophiko lwakaCommunity Services. UKunene uqale wafisa ukuthola ukuthi ngabe iWar Room iyawusebenzela yini umphakathi. Phakathi kwezingqinamba ezithulwe ngamalungu omphakathi bekuwukungafiki kweminye yeminyango kaHulumeni,

UMnyango Wezemfundo noWezokuthukiswa Komphakathi kaWard 5 bahlezi beqinisekisa ukuthi baba ingxenye yale mihlangano bese

bethola izinkinga ezibhekene nale Ward.”

Nezinhlangotho zasemphakathini ziba ingxenye yale mihlangano. Obemele inhlangano iMzansi Youth in Business (UYB) uNks uNonjabulo Khuzwayo uthe: “Sinohlelo lokuthukiswa umphakathi olubhekene nobhubhane ukhuvethe. Sinosonhlalakahle nabantu abazungeza umphakathini ukuhlola izikhala lapho umphakathi usalele khona. Inhlalo yale nhlangano ukusebenza wonke amaWard aseMsunduzi. Siqale kuWard 2

sisazoqhubekela kwamanye. Ewadini ngayinye sihlala inyanga eyodwa.”

Obemele uMnyango Wezemfundo uNkk uHlengiwe MaDlomo Phoswa uthe: “KwaWard 5 akukhule neze isibalo sabantu abathelekayo siyakhula. Lezi zibalo sizibona ngabantu abasebenzisa umtholampilo wethu kuphela kangakanani laba abasebenzisa eminye kanjalo nodokotela abazimele. Sidinga ukuqhamuka nohlelo lokuthi sizobafundisa kanjani ukuba bazivikele. Ngelanga cishe sihlala abahlanu, uma

sekubuya imiphumela abathathu basuke sebenokhuvethe. UMqondisi wesifunda uSindi Mbambo ukhiphe umyalelo wokuthi labo abake basondelana nosekutholakale ukuthi usethelekile nabo bahlolwe kungaze kulindwe ukuba bakhombise.

Okuvelile kulo mihlangano ukuthi ophikweni lwezamapaki e-Edendale banogandaganda owodwa osebenzayo okwenza ukuthi kube nzima ukuthi baphendule ngesikhathi ezikhaweni abazitholayo njengokukhula kukatshani ezinkundleni zemidlalo kwaVulindlela, e-Edendale naseMbali kanjalo naseduze komgwaqo.

Odabeni lokwentuleka kwamanzi kwaVulindlela iminyango kanye nobuholi bomphakathi banxuse uMasipala ukuba uqhamuke nenye indlela yokhlinzeka umphakathi ngamanzi ngoba eyezimoto ezizathuthayo ayanele namathangi amanzi kuba isixazululo sesikhashana. Phakathi kwezindawo azibalile uKhumalo lapho ukuthathwa komhlaba kuphezulu eMsunduzi iNingizimu yoMsunduzi kube i-Ambledon 3, iThe Farm Shenston, iMarikana, iHerewood, i-Azalea

Cemetery, i-Unit H Warworks, iShortts Retreat kanti enhla noMsunduzi iGlenwood, iBishopstowe, iSite Eleven Ottos Bluff, iPeace Valley 3, iSignal Hill, iYellowwood Place, iNhlalakahle, iBeacon Hill Farm kanye nase-Ezinketheni.

UKhumalo uthe ezinye zalezi zindawo zihlonzwe njengalezo okuzokwakhiwa kuzo izindlu zikaHulumeni kanti uMkandlu usuziyise kuMnyango Wezokuhlaliswa Kwabantu sekulindwe ukuba kuqhubeka umsebenzi. Ezinye zazo uMasipala uezinhlalo zokuthukiswa izindawo ngazo. Uqhube ngokuthi inkinga ngokuthathwa ngokungemvume komhlaba sekube ngeyewe lonke ezikhathini eziningi okwenziwa iqeqebane labantu abahlele okuthize ngenxa yezizathu ezahlukene kugcine kuhlukomezeka labo abathengile kubona.

“Ukuthathwa kwezindawo uma siqoqa ulwazi siwuMasipala sike sithole ukuthi abantu basuke besondela edolobheni, ukungasheshi kakhulu kokwakhiwa kwezindlu, ukusondelela amathuba emisebenzi, indlala kanye nokwantuleka kwamathuba omsebenzi,” usho kanje.

UKhumalo uthe kunamakomiti asunguliwe ukuba adayisele abantu umhlaba ngokungemvume elutha izakhamuzi, lokhu uMkandlu usuyazi ngakho. “UMasipala usezinhlalweni zokuthathela i-Anti-Land Invasion Policy (2020) ehlose ukunqanda ukuthathwa komhlaba nokugwema ukunyuka kwesibalo semijondolo, iphinde ikhulume nezinhlelo zokuhlaliswa kwabantu nokuthukiswa kwezindawo,” usho kanje.

Uthi uMasipala usebenzisa izindlela ezizonqanda ukuthathwa komhlaba. Okuseqhulwini uphiko iDevelopment Services seluhlonze umhlaba ongaseshensiswa ukuthukiswa umnotho nabatshalizimali edolobheni okuzolekelela ekutheni kudaleke amathuba emisebenzi kuzakhamuzi kuphinde kulilwe nodaba lokuthathwa komhlaba.

UKhumalo uphethe ngokuthi baxwayisa izakhamuzi futhi bavikela nalabo abazozithola sebethenga umhlaba kaMasipala ngokungemthetho. “Izakhamuzi kumele zazi ukuthi sekwakhiwe uphiko iRapid Response olusungulelwe ukuqapha izindawo zikaMasipala,” kusho yena.

USOMLOMO woMsunduzi iKhansela u-Eunice kaMajola Zondi uthi bafisa kungabi inyanga eyodwa kuphela ukukhuluma izinto zabantu besifazane kepha kube unyaka wonke.

“Ukungena emlandweni wosuke slwabesifazane ngokwepolitiki, kunabantu abalilwela aluvelanga lwaqhamuka lwase lwabungazwa kepha kunabantu abalwa kwachitheka igazi, abanye badlula emhlabeni. Omama abanjengoNkk uLillian Ngoyi, uNkk u-Albertina Sisulu kanjalo noNkk uWinnie Madikizela-Mandela nabanye abaningi abenza isiqiniseko ukuthi siyabonakala njengomama baseNingizimu Afrika,” kusho uSomlomo.

Uthe kuningi ababekulwela ngengcindezelo yangaleso sikhathi. UkaMajola uthi omama bangena ezindaweni eziningi, ngaleso sikhathi

kwakuyingcindezelo yabantu besilisa kanye nabesifazane eyayihlanganisa wonke umuntu, okwakungabantu besilisa, abesifazane kanye nentsha, eyagcina inqotshiwe.

Uqhube wathi njengabantu besifazane kusanezingqinamba ekuhlangabezana nazo njengokungena kwezomnotho okungakabi lula eNingizimu Afrika. “Njengamanje kusanabantu abathile abaziwayo ukuthi baphethe umnotho waseNingizimu Afrika iningi labo abamhlophe besilisa. Njengabantu besifazane siyafisa ukuthi singene sibe ingxenye yomnotho waseNingizimu Afrika.”

Uthe ziningi izinkinga ezibhekene nabantu besifazane le osekukhulunywa ngayo manje okuwukhulumeza ngokobulili ingezinye zazo futhi ngeke bayeke ukukhuluma ngayo bengakaboni ukuthi leyo nkinga seyixazululekile futhi bagculiseka. USomlomo uthi basazoqhubeka bayilwele futhi babone ubumqoka babantu besifazane.

Kepha kukhona le yokuhlukumeza ngokomoya lapho uzizwa umncane njengomuntu wesifazane, uzizwe uphelelwa nayisithunzi, lobo buhlungu budlula lobu bokuthi ushayiwe, lolo hlobo lokuhlukumeza lubiza ukuthi sihlangele singabesifazane sibuke

ukuthi sibhekana kanjani nalezo zinkinga. Inkinga ngalolu hlobo lokuhlukumeza ngeke uze ume ngalo ngisho enkantolo ngoba akuvamile ukuba nobufakazi,” usho kanje.

Uthe okunye okufanele kubukwe ukukhuliswa kwezingane ukuze

zizibone zilingana kusuka zisakhula ngoba lugotshwa lusemanzi. Uthi inkinga iqala izingane zisencane lapho eyomfana ikwazi ukuphuma ekhaya kepha eyentombazane ivaleleka, imisebenzi yasekhaya ingabiwa ngokulingana, kuba

nemisebenzi yengane yentombazane lokho okuze kufike esigabeni lapho nomzali engasakwazi ukusilawula lesi simo azifaka kuso enganakile ukuthi utshala imbewu yokungalingani ngokobulili.

Uqhube wathi emsebenzini kuyazanywa ukuba kulingwane ngokobulili ngokwamaphesenti, imiholo efanayo kodwa nakhona kusadinga ukuba kusetshenzwe mbijana. Uthe okunye okumqoka usiko athe kumqoka ukuba abantu besifazane bakwazi ukuhlukanisa isiko nokulingana (50/50) okuhlezi kukhulunywa ngawo nangendlela abantu abawubuka ngawo kuze kubonakale ukuthi cishe abakuqondi lokhu.

“Size siwufake nala okungafanele khona singabantu besifazane. Lolu daba luka-50/50 kumele lusebenze ezindaweni ezinjengasemsebenzini njengokuthi uma ngisebenza kumele ngibonakale ngendlela efanayo neyomuntu wesilisa futhi nami ngizinikele ngendlela efanayo emsebenzini wami njengomuntu wesilisa, okuholela ekutheni sihole iholo elifanayo namathuba okukhula emsebenzini afane,” kusho ukaMajola.

Uphethe ngokuthi abantu besifazane abangagqibi izinto abazenzayo ezingalungile basebenzise eka-50/50. “Okumqoka ukuthi sibuke lento yenhlonipho, siyihlanganise nenqubo yasekhaya ngalokho sizokwazi ukuwusebenzisa ngendlela lo 50/50 owawubekelwe kona.”

UMSUNDUZI ngenye yezindawo ebe nezibalo eziphezulu zabahaqwe ukhuvethe edolobheni, emalokishini nasezindaweni zasemakhaya kanti akugcini ngokugula kwabantu kepha nesibalo sabadlula emhlabeni siyakhuphuka. UMnyango Wezempilo kanye noMasipala wesifunda uMgungundlovu banqume ukuhlaba ikhwelo beqwashisa izakhamuzi zaseMsunduzi ngokubhebhethaka kwaleli gciwane.

Lo mkhankaso oqhutshwa uMasipala wesifunda uqale emtholampilo eMafakatini wadlulela emarenki amatekisi ngenhloso yokuzama ukuqwashisa abantu abaningi. Isikhulu esiphezulu sesibhedlela i-Edendale uNkk uNeliswe Nxaba kanye nesomtholampilo uNks uSimangele Zondi bebeyingxenye yalabo abebehamba beqwashisa.

UNks uZondi uthi isizathu esenze banquma ukuba nalo mkhankaso eMafakatini ukuthi ziphezulu izibalo zabahaqwe ukhuvethe khona kanti kunenkoleloze yokuthi lesi isifo sasedolobheni lesi. “Siyazama ukufundisa ngokhuvethe nokuthi lukhona futhi iziphizindlela abantu abangagwema ngazo ukuthi batheleleke, bayafundiswa nezimpawu zalo. Uma amalungu omphakathi ezosebenzisa umtholampilo ayahlolwa amazinga okushisa emzimbeni, abuzwe nemibuzo ethile ukuze sikwazi

ukuhlonza osehaqekile.”

Uqhube wathi kunezinye izakhamuzi ezingakhulwa ukuthi ukhuvethe lukhona kodwa khona kunjalo abapheli amandla ukudlulisa umyalezo bagcizelele ukuthi leli gciwane likhona futhi aziziphephise. Uthe basebenzisana nezisebenzi zase-Edendale kanye nenhlangano engenzi inzuzo iCaprisa. Ngesikhathi besahlaba lo mkhosi bahlole izakhamuzi ezingama-61 okuthi sezifundisiwe ngezimpawu zalesi sifo zase ziphumela obala ukuthi kukhona ezikusolayo.

“Uma kukhona okutholakale ukuthi unokhuvethe sisebenzisana nalabo abahlangane naloyo muntu bese behlolwa nabo. Abaningi bahlolwa e-Edendale ngoba banezinsiza zokulandelela abathe bahaqwa ileli sifo. Engibona engathi kusalele nokwenza ukuthi izibalo zikhuphe ekubeni kusendaweni yasemakhaya ukuthi kunezinkolelo njengokuthi uma umuntu enezihlungu esifubeni abantu bacabanga ukuthi idliso, okunye indaba yokuhlangana njengemigcawo kule ndawo omakhelwane basagwala lapho kunesifo khona, kanjalo nasematekisini abakaboni kumqoka ukufaka izimfonzo nokuqhelelana,” usho kanje.

Uthe abantu bayabafundisa ukuthi uma bezozigcina ngabodwana besekhaya yini elindeleke kubo njengokuthi kumele umuntu ahlale yedwa, asebenzise izitsha zakhe aphinde angasondelani namuntu. Uthi kulula ukwenza lokhu

emakhaya ngoba izindlu ziningi futhi kunorawondi lapho bezivalela khona. “Uma kukhona otholwe enalesi sifo wayalelwa ukuthi azigcine ngayedwana bekungakenzeki ukuthi kutholakale omunye esesimhaqile osemndenini,” kusho yena.

Uthe ubona umtholampilo wabo unendima oyiklamayo ukunqanda ukubhebhethaka kwaleli gciwane ngoba nanoma ubani owusebenzisayo uyafundiswa ngalo ngokulandela imyalelo ekhishwe uMnyango Wezempilo, ngalokho bayakhulwa ukuthi ulwazi

abaludlulisela emphakathini luzoze luzwele kakhulu futhi lube nesisindo.

UNks uZondi uthi njengoba kusendaweni yasemakhaya bayabafundisa ngamagama adume sekunokhuvethe njengelithi screening, quarantine no-isolation.

“Bebaba nokuthuka uma ubabizela ngasese uma sibahlola bese siyabachazela ukuthi kusebenza kanjani futhi imibuzo esibabuza yona ihloseni.”

Ube esenxusa umphakathi ukuthi ulandele imigomo ebekiwe njengokungahlangani ndawonye

futhi bazi ukuthi akusizona izinto zesiZulu kuphela ezigulisayo zikhona nezifo.

UNkk uNxaba unxuse izakhamuzi ukuthi zingakholelwa kulokho ezikuzwayo kepha ziye kwabezempilo abaqeqeshiwe. “Ngizazi ukuthi izakhamuzi ziyakholelwa kumhlonzane kepha kunabantu obagulisayo. Akukaqinisekwa ukuthi umhlonzane uyalulapha yini ukhuvethe. Ingakho uthola ukuthi abanye bavele baphalaze noma bagule kakhulu kunakuqala ingoba usuke ungalholiwe lo esiwukha entabeni. Okwesibili nesikali sisuke singasazi esilapha kahle uma sitsshelana sodwa lapha emakhaya ngoba omunye uphuzi inkomishi yonke omunye isipuni,” kusho uNkk uNxaba.

Unxuse izakhamuzi ukuba zingahlali emakhaya uma zizizwa zingaphephile waphinda wazazisa ukuthi awukabi bikho umgomo wokhuvethe, nalabo abadla imishanguzo yezifo ezithize bangayiyeki ukuze baphile. Uphinde wanxusa izakhamuzi ukuthi zisebenzise izinkundla zokuxhumana ukuxhumana nezihlobo zazo nabathandiweyo bazo.

IMeya uThebolla ithetha: “Lolu hlelo siluqambe ngelewalkathon inhloso yethu ne-UYB ukuxwayisa ngezinkinga zokuhlukumeza ngokobulili. Sifisa ukufinyelela kubantu abaningi ukuqinisekisa ukuthi bayabazi ubungozi futhi siyabonisa nabo ukuthi singenzenjani ukwehlisa izinga lokuhlukumeza abantu besifazane, izingane kanye namadoda.”

LAPHO kulindeleke ukuba sinyuke isibalo sabantu abadlula emhlabeni ngenxa yokhuvethe noHulumeni ukuba aqhamuke namaqhingasu ukuthi asebedlule emhlabeni bathole izindawo zokulondolozwa njengoba abanye bebheka izindawo zamathuna, kuqondane nokuthi uMsunduzi ulungisa indawo yawo yokulothisa izidumbu eseyinesikhathi eside ingawusebenzeli umphakathi.

Ukulahlekelwa isihlobo noma othandiweyo kuyinto ebuhlungu ingakho kuba sengathi uma sewumvalelisa angahamba ngesizotha. Abantu bakhetha izindlela ezahlukene zokulondolozwa, abanye leyo ejwayelekile yokumbelwa abanye eyokushiswa. EMsunduzi emveni kwesikhathi eside abakhetha eyokushiwa bengakutholi ukuhamba ngendlela abayifisayo, amalungu ekomiti leCommunity

Services avakashele indawo yokulothisa ebingasebenzi.

USihlalo waleli komiti uKhansela uLinda Madlala uthe: “Sesiyaluphothula uhlelo lokulungisa indawo yethu esinesikhathi eside ingasebenzi ngenxa yezinkinga ebe nazo. Kuyasithokozisa ukuthi izakhamuzi zaseMsunduzi ezinesifiso sokugcinwa ngale ndlela sezizokuthola lokhu ezikufisayo, endaweni yazo, lokho kuwukuletha izinsiza emphakathini.”

UKhansela uMadlala uthe izakhamuzi zaseMsunduzi bekudingeka ukuthi ziye eCato Ridge ukuze zithole indlela yokulothisa izihlobo zazo. “Indawo yethu ngaphambi kokuthi ivalwe yayinenkinga yokuthi oyisebenzisayo uma eyivula emva kwesikhathi esibekiwe okumele engabe isidumbu sesiwumlotha, athole ukuthi mhlawumbe asikashi sonke, kusanezitho zomzimba ezithize, lokhu okudala ukucindezeleka ngisho

engqondweni ezisebenzini,” kusho uKhansela uMadlala.

USihlalo uthe amalungu ekomiti abone kumqoka ukuba avakashele le ndawo ukuhlola inqubekela phambili. Leli komiti lakhiwa amakhansela ali-13 amaqembu epolitiki ahlukahlukene. “Imibuzo amalungu ekomiti abenayo ukuthi umphakathi waseMsunduzi uzoyisebenzisa nini le ndawo futhi yini eshodayo? Kuyasithokozisa ukuthi nokho umsebenzi sewuqhubekile futhi sekusele kancane njengoba lokho okumqoka sekwenziwe sekukhulungisa nje lokhu kokuthi indawo ibukeke kahle,” kusho yena.

Uqhube wathi ikomiti lanelisekile ngomsebenzi owenziwa inkampani eqashelwe ukwenza lo msebenzi. “Izisebenzi zethu uma zihlola umsebenzi osewenziwe yile inkampani zithi okungenani ngama-70% kuya kwama-80% omsebenzi osuphothuliwe.

Uthe lokhu abakwenzayo akusikhona ukuphendula kukhuvethe kepha kuwukulungisa indawo yabo ebese ingekho esimweni. “Yebo kuqondanile nokuthi kuhlasele lolu bhubhane. Sibone kumqoka ukuthi silungise le ndawo ngokuphuthuma ngoba ukusuka lapha eMsunduzi beya eCato Ridge ngoba befuna ukulothisa lokho bekuba umthwalo kuzakhamuzi zaseMsunduzi zibe zinayo indawo yazo yokulothisa.”

Osebenza kwaMasipala uMnu uMandla Zuma elandisa ngobekuyinkinga kule ndawo uthe: “Izindonga eziphakathi lapho kufakwa khona isidumbu beseziwa ngenxa yokushiswa okukhulu okubakhona ngenkathi kushiswa isidumbu, izivalo bese zinenkinga obekungaholela ezintweni ezahlukene mhlawumbe kube ngenxenywe yomzimba ephumayo ngenkathi kusha, okunye phambilini bekungafakiwe okunqanda ukushiswa ophahleni manje sekufakiwe.”

Uqhube ngokuthi inkampani

ebilungisa yeluleke uMasipala ukuthi nakuba beyilungisile eminye imishini esebenza kule ndawo kepha kumele uthenge emisha emveni kwesikhathi ngoba ekhona iwuhlobo oludala.

Ilungu lekomiti uKhansela uMehmood Oumar ubuze umnikazi wenkampani elungisayo ukuthi isiphi isiqiniseko abazosithola njengoMasipala ukuthi emveni kokuba le ndawo seyiqalile ukusebenza ngeke ibanike izinkinga. Uphendule ngokuthi bazobe beyinakekela isikhathi esingangonyaka emveni kokuba seyiqalile ukulothisa.

UKhansela uMadlala uphetha ngokuthi: “Sithanda ukuxolisa kuzakhamuzi ngokungasebenzi kwale ndawo nezinkinga ezibuhlungu obekumele zibhekane nazo ngenxa yokungasebenzi kwale ndawo. SiwuMkhandlu sizokwenza konke okusemandleni ukuqinisekisa ukuthi izinsiza ezinjengalezi ziyafinyelela emphakathini.”

Ekhulumana naleli phephandaba, uSuperintendent uBheki Xulu, ucacise ngamaqhingasu abawasebenzisayo ukunciphisa isiminyaminye sezimoto.

Uthe kuyisifiso sikaMasipala ukwehlisa isikhathi sokuhamba ukusuka eScottsville ukuya edolobheni kube amaminithi amahlanu kuya kwayishumi uma kunezimo eziphazamisayo, amaminithi angama-20 ukusuka e-Edendale noma angama-30 uma kunezimo ezingaphezu kwamandla. Kufanele kube ngamaminithi

angama-20 ukuhamba usuka eNorthdale noma angama-30 ngaphansi kwezimo ezingalawuleki.

UXulu uthe ikhona indlela amaphoyisa omgwaqo nabasebenzisa umgwaqo abangasebenzisana ngayo.



Wengeze ngokuthi amaphoyisa omgwaqo kumele atshalwe kuzona zonke izindawo eMsunduzi hhayi e-Edendale kuphela lapho kunokwakhiwa komgwaqo okukhulu. “Akuphusile ukugxila endaweni

eyodwa, kubalulekile ukugcina imigwaqo yethu ivulekile ngoba lokhu kuzoqinisekisa ukugeleza komnotho nokuhluzeka ngezidingo eMsunduzi,” kusho uXulu. Uthe akwamukelekile ukuthi

abantu bafike emveni kwesikhathi emsebenzini ngenxa yokucinana kwezimoto emgwaqeni.

Mayela nezikhathi ezisetshenzwa amaphoyisa omgwaqo uthe: “Amaphoyisa omgwaqo aseMsunduzi asebenza kusukela ngelesi-6 ntambama. Abangena ekuseni baqala ngelesi-6 bashayise ngelesibili ntambama, abasebusuku baqala ngelesi-11 ekuseni kuya kwelesi-6 ntambama.”

Uthe udaba lwezimoto ezisetshenziswa amaphoyisa luseyinkinga futhi wethemba ukuthi luzoxazululwa maduze. UXulu uthe ukuqashwa kwamaphoyisa angama-25 kwehlise umthwalo.

“Ukufika kwala maphoyisa kususize kakhulu njengoba sesikwazi ukufinyelela ezindaweni eziningi esikhathini esifushane futhi singakwazi ukutshala amaphoyisa ezimpambanweni ukuvumela ukugeleza kwezimoto. Sesiseduze ukuba sifinyelele lapho esifuna ukuba khona,” kuphetha uXulu.

UMasipala uqinisekisa ukuphepha kwesikhumulo

Kutholakale ukuthi izinga lokuphepha esikhumulweni sezindiza i-Oribi lisezingeni elijwayelekile

KUJWAYELEKILE ukuthi abantu bacabange ukuthi ezokuphepha kulezi zikhumulo zezindiza ezincane aziqinile njengalezo ezinkulu. UMsunduzi lokho usukukhombise ngezenzo ukuthi kungamampunge ngoba inhlango okuyiyo ebhekelela ezokuphepha ezikhumulweni zezindiza eNingizimu Afrika iCivil Aviation Authority (CAA) iqinisekise ukuthi izinga lokuphepha kwesikhumulo sezindiza i-Oribi lisezingeni elifanale.

ICAA ebika ehovisini likaNgqongqoshe Wezokuthutha yiyo ebeka imigomo ukuthi isikhulumo sizosebenza kanjani. Isizathu sokuthi kube khona lolu hlaka ukuqinisekisa ukuthi asikho isikhulumo esibuthaka, izinswelaboya ezizosebenzisa ukufinyelela lapho eziphokophele khona. Bekujwayele ukutholakala ukuthi izinswelaboya zilokhu zisebenza lezi zikhumulo noma zingathathela kanjani inqobo uma zingasebenzisanga lezi ezinkulu, uMsunduzi ukuqinisekisa ukuthi lokhu akwenzeki kwesawo. Obambe njengesikhulu sesikhumulo, uMnu uMazwi Mngwengwe, uthe okumqoka kubo ukuqinisekisa ukuthi

umphakathi uphephile. “Sikubeka phambili ukuphepha komphakathi, asifisi umuntu osebenzisa lesi sikhumulo athuke impilo yakhe seyisengcupheni, ingakho senzi isiqinisekiso sokuthi lokho esikuyalelwa yilolu hlaka siyakulandela, asithathi izindlela ezisheshayo,” kusho uMngwengwe.

UMngwengwe echaza lolu daba uthe lol hlaka uma lungaxegisa isandla ngokuqinisekisa ezokuphepha lokho kungabeka engcupheni nezikhumulo ezinkulu, iphinde ibeke engcupheni impilo yabagibeli ngoba luphinde lubheke izinto eziphathwa ngabagibeli ezingavumelekile ebhanoyini. “Lokho kungenzeka ukuthi umgibeli ubengazi ukuthi uphethe into engavumelekile ebhanoyini, okungasikhona ukuthi ingoba ehlose ukubhubhisa abantu ebhanoyini,” kulanda uMngwengwe.

Isikhumulo sezindiza zase-

Oribi sinenkampani eyodwa enamabhanoyi okuyi-Airlink elayisha kahlanu aphumayo, kanye nakahlanu angenayo. Lesi sikhumulo siphakela i-OR Tambo International Airport. I-Oribi iklama indima enkulu emnothweni wendawo ngoba osomabhezini basebenzisa lesi sikhumulo ukubamba imihlangano lapho bezotshala imali eDolobheni.

Lesi sikhumulo asisebenzeli uMasipala nje kuphela kepha siphinda sivule amathuba omsebenzi kanjalo nosomabhezini. “Kunabantu abasebenzayo abaqashwe inkampani yamabhanoyi (airline), kanye nezinkampani ezisebenzayo ngaphansi kwalesi sikhumulo sezindiza,” kuchaza uMngwengwe.

UMngwengwe ufisa izakhamuzi saseMsunduzi zisisebenzise lesi sikhumulo ngoba ingezinye zezinto ezakhela uMasipala inkece. “Nanoma iliphi ilungu lomphakathi liyazuza

ngokugibela komuntu indiza, ileyo mali esiyisebenzisayo ukuphinda sihlizzeke umphakathi ngezinsiza, ngalokho uma amalungu omphakathi ezosebenzisa lesi sikhumulo izokwanda imali ezolekelela ekuhlizakeni kwezidingo emphakathini,” kusho uMngwengwe.

Uqhube wathi izinhlelo abanazo manje njengoMasipala ukuheha ezinye izinkampani zezindiza njengoba kunenkampani eyodwa. “Isifiso sethu ukuheha ezinye izinkampani khona abagibeli bezokwazi ukuzikhethela, kanjalo bagibele nalokho okuhambisana nephakethe labo. Siyazi ukuthi into esishayayo ukuthi lezi zinkampani zize kulesi sikhumulo (Oribi) ukungabi nengqalazinda ekwazi ukuthi ihambane nalezi ezinye izindiza. Ezinye izindiza uthola ukuthi zidinga indawo ende zisagijima phansi, thina eyethu uthole ukuthi imfishane, lokho kugcina kuphikisana nokudingwa

ilezo zinkampani kodwa sizimisele ukukulungisa,” kulanda uMngwengwe.

Uveze ukuthi umphakathi uke uzitshele ukuthi amanani amba eqolo bese uya esikhumulweni sezindiza esiseThekwini, “Abantu babheka ukuthi mhlawumbe thina siyabiza ngama-R200 bese bangasisebenzisi lesi sikhumulo, uthole beya eThekwini banganzakhi izindleko ngenkathi beta uphethroli, imali yetollgate kanye neyokukhokhela indawo yokupaka imoto. Zonke lezo zindleko ezigcina zingaphezulu kunentengo yethu futhi bebenonga nesikhathi sabo.”

Akungatshazwa ukuthi izikole ezisezingeni lomhlaba kumabanga aphansi ziseMsunduzi, kanjalo nezingane zalabo abadla izambane likapondo zifunda ezikoleni zaseMsunduzi, uMngwengwe uthe lezi zingane zakwezinye izifundazwe zisebenzisa lesi sikhumulo ukuya emakhaya uma kuyizimpelasonto nokuya ezikoleni. “Ingingi labantu abasebenzisa lesi sikhulululo kubuye kube ngabazali balezo zingane kanye nabatshlizimali, othola ukuthi uzofika ekuseni bese ebuyela emuva ntambama,” kusho uMngwengwe.

Lesi sikhumulo silima indima emqoka kubafundi bezikole, kungaba abasemabangeni aphansi asebefuna ukuthola ukuthi yini abafisa ukuyifundela, kanye nalabo abafisa ukufundela ukushayela amabhanoyi.

“Lesi sikhumulo siyabemukela abafundi abafisa ukuzobona ukuthi sisebenza kanjani, siphinde seluleke labo abanesifiso sokusebenza kulo mkhakha ukuthi iziphi izifundo abangazenza siphinde sibe nesikole esifundisa ukushayela amabhanoyi.”

ONGOTI kwezamabhizinisi bathi ukukhangisa ezinye zezinto ezimqoka ekusimamiseni ibhizinisi. UMsunduzi usungena endleleni entsha yokukhangisa idigital advertising. IMeneja yesikhumulo sezindiza i-Oribi uNks uNontobeko Mofokeng banqume ukufaka obhazabhaza bamathelevishini okukhangisa kulesi sikhumulo ukuze kube nokuxhumana nezakhamuzi zaseMsunduzi.

“Sizoqhakambisa izinto ezinhle ezenzeka eMsunduzi kanjalo nokuqhuba imikhankaso okungaba ukuphepha, ukuvikela noma ngabe yini eyenzeka esikhumulweni sezindiza. Lama thelevishini azolekelela ukwakhela uMasipala imali ngoba azophinda asebenze njengesikhangisi,” kusho yena.

Uthe nosomabhizinisi bavumelekile ukukhangisa njengoba uMasipala uphinde ube namabhodi okukhangisa futhi noma ibaphi osomabhizinisi nezinkampani zangaphandle bayabagququzela ukuba bayisebenzise le ndlela yabo ukuba bakhangise.

“Ukukhangisa usebenzisa idigital kushibhile futhi kuhlala isikhathi eside uma kuqhathaniswa namaphepha, kuya ngokuthi inkampani inesifiso sokukhangisa isikhathi esingakanani, siqala esikhathini esingakusonto.” Uthe sebhlose ukusebenzisa isikhumulo sezindiza

njengebhizinisi elizofakela uMasipala imali. Uqhube wathi abafuni ukwakha imali ngabagibeli bezindiza kuphela kepha nangezinye izindlela. “Sibonile ukuthi isikhumulo sinawo amandla okuba isizinda sokukhangisa ngoba kunabantu abaningi abasisebenzisayo futhi abahamba ngezinyawo njengoba kufika abazolanda abagibeli, osomabhizinisi nabafundi kusho ukuthi kungena lonke uhlobo lomuntu,” usho kanje.

Uthe inhloso ukwakha imali ngesikhathi beqhakambisa amabhizinisi kanti bazokhangisa noma imaphi amabhizinisi asemthethweni kodwa azocutshungulwa njengoba kunenqubomgomo ebalawulayo futhi kusayinwa inkontileka.

Uveze ukuthi lokhu kusebenza ezikhangisi zamaphepha nakwezinamekwa odongeni (wallpapers).

UNks uMofokeng uthe ngendlela uMasipala olusebenza ngayo udaba lokukhangisa uhlose ukwenza isiqiniseko sokuthi namabhizinisi amancane ayakwazi ukukhangisa.

Ukuthi inkampani izokhokha malini kuncike ekutheni isikhangisi singakanani uma kungesadongweni noma iphepha, lapho kubalwa nge-m2 nokuthi hlobo luni lwesikhangisi olufunwa ibhizinisi,” kusho yena.

Uqhube wathi ukukhangisa kudigital kushibhile kunalo lonke olunye uhlobo lokukhangisa olukhona eMsunduzi ngoba ayikho into esetshenziswa uMasipala ngaphandle kukagesi futhi okungadingi ukuthi uMasipala unakekelele impahla.

Uthi okuwumsebenzi wofake isikhangisi ukuthi njalo emva kwesonto ayohlola ukuthi ngabe sisavela ngendlela ayifisayo yini.

“Sinxusa abantu ukuthi basebenzise isikhumulo sezindiza sabo lapha eMsunduzi baphinde bakhangise kuso ngoba izinkampani ezinkulu ziyalisebenzisa leli thuba kodwa lezi ezincane okuyizo ezilidinga kakhulu azifiki ukuzoxoxisana noMasipala.

Ngenxa yokhuvethe amabhizinisi ashayekile ngakho-ke ukuze ibhizinisi liqhubeke libe kubiza ukuthi limakethwe ngendlela lokhu uMasipala akudingayo ngoba ukufadabala kwamabhizinisi kubulala umnotho wendawo.

Sizimisele ukuxoxisana nangamanani ngoba lesi sikhathi sishaye kwazwela emabhizinisini,”

kusho yena.

Kusuka zintathu kuNtulikazi uNgqongqoshe Wezokuthutha uMnu uFikile Mbalula wamemezela ukuthi isikhumulo sezindiza i-Oribi singezinye zezikhumulo ezikulungule ukuvulwa ngenxa yokuthi siyahlangabezana nemigomo nemiyalelo yokhuvethe.

Ukuze isikhumulo sivulwe kwakumele sihambise kulo Mnyango nakwaSouth African Civil Aviation Authority umbiko wokuthi sizosebenza kanjani ukunqanda ukubhehetheka kokhuvethe.

UNks uMofokeng uthe izindiza zabuya amasonto amabili kodwa ngenxa yemigomo ethile ebalawula ukuhamba ababanga baningi abantu abezebenzisa okuholele ekutheni zihoxiswe.

“Kulesi sigaba sokuvalwa kwezwe akusadingeki zimvume uma unesifiso sokundiza,” usho kanje.

Uphethe ngokuthi kukhona amabhizinisi avalile ngalesi sikhathi semvalelwakhaya kuyimanje kunezikhala ezikhona zokwenza ibhizinisi kulesi sikhumulo ngakho onesifiso sokumqasha indawo yokuthengisa angaya kwaMasipala.

“Indlela esiqoka ngayo inkampani sibheka ukuthi okuthengiswayo kukulungele yini ukudayiswa esikhumulweni futhi lizokwazi yini ukuba ibhizinisi elisebenzayo nalo likwazi ukwenza inzuzo,” kusho yena.
