1. WELCOME AND APPLICATION FOR LEAVE

The Chairperson Councilor S Khumalo officially opened the meeting, he thanked and welcomed Forum members and declared the meeting open. He requested that all Forum members introduce themselves. Apologies were received on behalf of the Honorable Mayor T Njilo, SANRAL, Environmental Affairs and Office of the Premier.

3. MSUNDUZI MUNICIPALITY STATUS QUO

(Item 4 of the Agenda)

3.1 DRAFT INTERGRATED DEVELOPMENT PLAN

The Manager for IDP took members through an electronic presentation, He highlighted the role and purpose of Msunduzi Municipality within the National and Provincial content, He gave and overview presentation of the IDP and highlighted the following;

- Key Strategies
- 2018/19 IDP review key challenges
- Institutional challenges and
- Turn around strategies

The Manager stated that interventions and corporation from Departments is critical, in meeting the National and Provincial Development plan as stated by the President in the State of the Nation address

He also stated that at a Provincial level Msunduzi Municipality is in line with the 7 strategic goals with regards to IDP namely

- Inclusive Economic Growth
- Human Resource Development
- Human & Community Development
- Strategic Infrastructure
- Environmental Sustainability
- Governance & Policy
- Spatial Equity

The manager informed the Forum of the new ward 19, that has been adopted by Msunduzi Municipality, He also stated that Geographically Msunduzi Municipality is well located compared to neighboring Local Municipalities. He also informed members of the forum that Msunduzi Municipality is highly populated compared to other Local Municipalities.

3.2 MUNICIPAL OVERVIEW ECONOMY GDP

The Manager also highlighted the share GDP at a Provincial level indicating that eThekwini had 62% share and Msunduzi Municipality having 10%. He further stated that Msunduzi Municipality had a high percentage growth compared to other Municipalities due to its location and Industries operating within the Msunduzi Municipality.

It was also stated that population growth in the Msunduzi Municipality was a concern as it pressures the Cities Infrastructure which needs to be considered when conducting Infrastructure planning, He further informed Forum members that the Youth population was highly motivated by the Universities as well as career opportunities.

The Manger IDP; informed members of the following challenges facing Msunduzi Municipality

4 MSUNDUZI MUNICIPALITY: INDUSTRIAL DEVELOPMENT STRATEGY

(Item 5 of the Agenda)

The Forum members were taken through and electronic presentation highlighting the project overview and the key elements that the Industrial sector need to be addressed in order to increase industrial investments in the City.

4.1 PROJECT OVERVIEW

It was stated that 108 actions had been identified by Msunduzi Municipality which needed to be linked with sectors IDP, it was also stated that the project had commenced 8 months ago.

- Situational analysis
- Sectoral analysis
- Potential analysis
- Land supply and demand analysis
- Project prioritization model
- Monitoring and evaluation matrix

4.2 PROJECT PURPOSE

It was stated that the project was to formulate a Local Industrial Development Strategy based on identified development needs, opportunities, competitive and comparative advantages in order to guide the Msunduzi Municipality to facilitate development as well as unlock industrial development potential, encourage private sector investments and create economic development and job opportunities for disadvantage communities.

It was also stated that Industrial Industries had identified the following as key requirements in terms of efficient and effective production;

- Infrastructure (Roads & Transport access)
- Land and spatial issues
- Human resource
- Water and Electricity

5 PRESENTATION DEPARTMENT OF EDUCATION

(Item 7 of the Agenda)

The Presenter took Forum members through the electronic presentation highlighting the following statics pertaining to matric pass rate. He also stated that as Umgungundlovu District education a contribution of 72% pass rate had been achieved. Adding that as a department a target of 90% Matric pass rate has been set for 2018.

5.1 CURRICULLUM INTERVENTIONS

The presenter informed the Forum members of interventions the Department had put in place projects to assist learners and teachers in achieving set targets.

5.2 INFRASTRUCTURE MANAGEMENT SERVICES REPORT

It was stated that the Department of Education had the following school projects

- Zuzulwazi Secondary School refurbishment and rehabilitation
- Woodlans Primary School new /replacement infrastructure assets
- uMvuzo Secondary School new /replacement infrastructure assets
- M L SULTAN Secondary School maintenance and repair
- Nkabini Primary School maintenance and repair

• Mehlokazulu Sec Major Repairs & Renovations

5.3 CHALLENGES

The Presenter also informed the Forum members that major challenges faced by the Department of Education, he added that strategies had been put in place to address the following challenges;

- Illegal invasion of DOE sites.
- Vandalism in schools
- Arson
- Limited funds for school maintenance
- poor workmanship by contractors
- IAs delay in awarding and appointment contractors
- Farm schools challenge in signing Section 14 agreements
- Water shortage

The Manager; IDP sought for clarity as to whom is responsible for the repair and maintenance of water meter within schools.

Members also sought for clarity with the enrolment of children living with disabilities, Members further sought for clarity as to the benchmark used in order to identify communities that need schools.

6. PRESENTATION DEPARTMENT OF SOCIAL DEVELOPMENT

(Item 8 of Agenda)

The representative; Department of Social Development took forum members through the electronic presentation highlighting the vision and mission of the Department.

6.1 STRATEGIC GOALS

It was stated that the Department of Social Development had the following strategic goals;

- To provide developmental social welfare to persons affected by substance abuse
- To render crime prevention services
- To provide developmental social welfare services to older persons
- Assist people with disabilities
- Assist families infected and affected by HIV Aids
- Assist victims of crime and violence
- To provide child care and protection services
- To provide youth development services
- To provide capacity development programs to non-profit organization towards creation of sustainability
- To promote population -related research, policy development and planning.
- To advocate and strengthen inter-sectoral collaboration and human resource development.

She stated that under Msunduzi Municipality currently the Department is servicing 39 wards and had offices in Vulindlela, Dambuza, Maswazini one stop shop and Central CBD.

Members raised concerns regarding children and people living on the street, as this is affecting the Cities development and investment, Clarity was sought as to plans and strategies in place to address the issue.

It was stated that programs had been developed to address the issue and implementation would proceed during the course of this year. Stakeholders such as SANCA are on board to assist those individuals living under the influence of drugs.

7. PRESENTATION DEPARTMENT OF PUBLIC WORKS

(Item 11 of Agenda)

The presenter took delegates through the electronic presentation highlighting the Departments major projects, budget allocations as well as project beneficiaries.

7.1 EXPANDING PUBLIC WORKS PROGRAMME (EPWP)

She stated that the Department of Public works was working with Municipalities through this program to address the issues of Poverty, unskilled youth, radical socio economic transformation in disadvantage communities.

7.2 <u>YOUTH EMPOWERMENT</u>

It was also stated that Msunduzi Municipality was not benefiting with regards to this particular program, however the Department has employed Eyesizwe Contractors to provide employment and skills to unemployed youth, she also stated that The department had hosted successful youth and women in construction summits, to give special attention to radical socio –economic transformation and growth opportunities.

7.3 KZN INTERGRATED GREENING PROGRAMME

The presenter informed members that the KZN integrated greening program focuses on;

- greening activities such as growing and planting indigenous and edible plants,
- collecting recyclable waste,
- restoring community forest assets,
- trading bicycles,
- water tank solar energy devices.

It was also stated that since its launch, thousands of trees have been planted and work opportunities have been created around the Province.

7.4 BUSARY AND INTERNSHIP PROGRAMME

It was stated that the Department had awarding nine bursaries deserving student within Msunduzi Municipality in the scarce skills disciplines in;

- Built Engineering
- Architecture
- Quantity Surveying
- Engineering
- Real Estate and Construction Project Management

She also stated that the Departments Internship program had employed 17 students

The Manager IDP requested clarity concerning the Departments Youth Project, as to how the youth of Msunduzi Municipality can also benefit from the project as currently Msunduzi Municipality is not benefiting.

In response it was stated that the youth program is aimed to assist all youth within the different Municipalities including Msunduzi Municipality, as the project will be coordinated within the Municipality.

8. PRESENTATION DISTRICT DEVELOPMENT AGENCY.

(Item 12 of Agenda)

The presenter took members through the presentation stating that Department of Corporative Governance took a resolution in 2012 which stated that all District have a Development agency, since the resolution ten Development Agency had been established across the Province.

He stated that the core mandate of the District Development Agency is to identify, package facilitate and achieve strategic goals for projects.

8.1 DISTRICT DEVELOPMENT AGENCY PROJECTS

It was stated that 180 thousand learners from disadvantage households had been identified and will be assisted with food in the third quarter of 2018, It was also stated that aid in the form of vegetable gardens will be provided for families of the 180 thousand learners.

He also stated that upgrading of Goat farms is in the pipelines and partnerships for import had been formed with relevant stakeholders. Adding to that it was also stated that projects to upgrade cattle farming as well as chicken farming was essential and engagements had been made with farmers in order to establish resources need to provide effective production as well as maintain close relations with the industry

9. PRESENTAION UMNGENI WATER

(Item 13 of Agenda)

The presenter from uMngeni water took delegates through the presentation. She requested that the Forum note that currently all dams were overflowing due to the constant rains experienced in the Midlands region.

It was also stated that uMngeni is in partnership with the Department of water & sanitation as the custodian of the country's water resource and that at local level within Pietermaritzburg uMgungundlovu and Msunduzi Municipality were water service authorities.

9.1 STATUS OF DAMS

It was stated that as of the 1st of March dam levels within uMgungundlovu District were reflecting the following levels;

- Spring Grove Dam 100.36%
- Midamar Dam 99.09%
- Mearns Dam 99.20%

It was also stated that uMgungundlovu District is the custodian of the water resources for the economic hub of KZN as the water used by Durban comes from uMgungundlovu District.

The presenter took delegates through uMngeni water project namely and the projected costs thereof;
