Councillors impressed with IRPTN progress



Workers busy on the site of the Intergrated Rapid Public Transport Network that will change the City's public transport system.

The Intergrated Rapid **Public Transport** Network (IRPTN) is well on track following the relocation of residents whose properties were encroaching the construction area.

This was part of the update presented to members of the Infrastructure Services Portfolio Committee at a meeting on May

In a report prepared and presented by acting IRPTN head Lindelwa Mngenela, committee members learned 23 properties along the road reserve resulted in delays but the matter has now been resolved.

The project currently has an

allocation of R208 million and to date over R50 million has been spent.

"There may have been challenges but we have worked them out," said Mngenela who expressed confidence that about 70% of the budget would be spent by the end of the 2017/18 financial year.

Msunduzi Deputy Mayor Thobani Zuma expressed the councillors' gratitude on the project update and stressed the importance of regular updates.

"This is a massive project for the municipality and residents. We hope that we will get regular updates so that we, in turn, can also inform the residents," said Zuma, who chairs the committee.

The report further revealed that 84 local labourers had been employed since the inception of the project.

In addition to this a total of 14 local sub-contractors have been employed since the start of the project covering areas including:

- * toilet relocation
- * tree felling
- * temporary line marking
- * erection of temporary
- * plant hire, water truck, tipper trucks, crane truck excavator

Aside from this, contractors also provided security services and medical examinasion on site.

Councillors were unanimous in the need for regular updates on the project that will bring a much needed facelift to the city's public transport system.

"We would like to be furnished

with information regarding the value of the work of the subcontractors," said committee member councillor Dumisani Phungula.

The report further explained that the IRPTN phasing consisted of six phases and its main aim was to intergrate all modes of transport with feeder routes feeding to the trunk route that is the backbone of the system.

As a further illustration to the progress made on the project, traffic lights have been erected and are expected to have electricity installed in the coming

The Msunduzi Municipality is one of many major cities in South Africa that are implementing the IRPTN with the overall goal of improving the quality of life for Msunduzi residents through the provision of an integrated public transport network that is rapid, safe and secure, convenient, clean, affordable, disability friendly and socially equitable.

The dominant public transport corridor, starting in Edendale in the south-west, is routed through the CBD and across the N3 freeway to Northdale, a distance of over 17km.

The coach acknowledged that this season's performance posed a challenge as a number of suitors in the form of big teams were trying to lure their players.

He said it would be important for the current squad to remain together for next season and the coming years to ensure success.

He promised local soccer fans that they would strive to play the brand of football that appealed to them.

"We want to make Harry Gwala Stadium a fortress by playing the kind of football that wins matches but is equally entertaining," said the chairman.

He reserved special praise for local supporters whom he labelled as the most loyal, as they had stuck with the team, even at the time when there was a prospect of relegation.



Revival and regeneration of Edendale

The social and economic exclusion of residents in Imbali and Edendale heightened the impact of political disenfranchisement. As the poor remain located at a substantial distance from economic opportunities, the dysfunctional city structure has increased transportation costs. On the other hand, the increasing spatial fragmentation of cities into wealthy and poor enclaves undermines the equitable distribution of public goods and

This trend creates serious problems of exclusions, with escalating social tensions, which is often exacerbated by the marginalisation of neighbourhoods.

In the South African context, unique forms of exclusion have arisen. Thus, township areas "excluded by design" have been created as a direct and deliberate consequence of apartheid policy. The National Treasury has identified the Greater Edendale area for township renewal and through the establishment

and development of an Urban Hub seeks to advance the transformation and regeneration of the Greater Edendale area. The merits of identifying Edendale are evidently based on the area's historical and current development challenges. It comprises the majority of the municipal area previously designated under apartheid.

As a national imperative, the Neighbourhood Development Partnership unit (NDP) duly introduced the Urban Networks Strategy to reshape urban spatial form and the proposed new direction is "a transit-orientated precinct investment planning, development and management approach aimed at strategic spatial transformation".

The primary focus is to stimulate and accelerate investment in poor, under-served areas by providing technical assistance and capital grant financing for municipal projects that have either a distinct private sector element or an intention to achieve this. The critical aspects of the NDPG Programme include the following:

- To direct and manage investment within identified priority areas;
- To inform and advance the orderly and desirable spatial development of identified priority areas by, inter alia, preparing development strategies and guidelines incorporating the preparation of a Development and Implementation Framework;
- To create a climate conducive to private sector investment and provide a clear spatial logic that would facilitate such decisions on investments and accordingly to encourage investment decisions, not only in pursuance of optimal returns, but also in support of a shared spatial vision for the City; and
- To deliver economic growth that does not continue to generate environmental loss, an environment threatened by poor resource management, resource intensive economic growth and a carbon dependent energy base.

The elements of this model are firstly, the primary network stretching across an entire urban area, consisting of primary nodes (including the typical CBD, established primary nodes and Urban Hubs to be supported or established in township areas) and the main movement lines or public transport linkages connecting the nodes.

It also includes the secondary network that consists of lower order nodes connected to the primary nodes or Urban Hubs via secondary public transport linkages.

The main point of intervention of the NDPG will be to support the establishment and improvement of the Urban Hub and in this way support the establishment and formalisation of anchor points in the primary urban structure in township areas where this is still lacking.

The Urban Hub is envisaged to function as a town centre for a surrounding residential area (township of cluster of townships), and in addition provide access to the rest of the primary urban network. In future editions we will unpack more on the Edendale Town Centre.

Land reform key for city development

sunduzi Mayor
Themba Njilo has
committed the
municipality to release land for
productive purposes in line with
the government's land reform
process.

Tabling the municipality's R4,9 billion budget during the council sitting on May 30, Njilo said the municipality would work with a range of stakeholders to speed up development through land reform.

"A number of housing projects in the Greater Edendale area are hamstrung by the reluctance of land owners to sell at an equitable and fair price. We are going to work with private land owners, national government departments and state owned enterprises to release land into the state's hands for productive use.

These are significant land parcels that are lying fallow, under-utilized or abandoned by absentee land lords, that will be expropriated and allocated to our people for their own advancement," said Njilo, during the sitting.

He also lamented under-

spending that he said was hampering progress in the city.

"The terrible consequence of this is to forfeit the money to the National Treasury.

This is a grave injustice for which there shall be consequences," the mayor added.

Included in the multi-billion rand budget are the following:

- * Addressing the problem of youth unemployment in partnership with the private sector and the youth organisations;
- * Strengthening the partnership with the private sector, labour and civil society to unlock inclusive growth, greater levels of employment and empowerment as well as structural transformation and seek reindustrialization of the local economy;
- * Increasing support for the revitalization of the township economy;
- * Harnessing the opportunities provided by the advent of the 4th Industrial Revolution, by modernizing key sectors of the economy and the state;
- * Speeding up the delivery of new infrastructure and paying

attention to the maintenance of existing infrastructure across the Msunduzi City Region;

* Upholding ethical leadership and integrity by intensifying the fight against corruption, collusion and maladministration, working in partnership with civil society; * Reconnecting with communities and unlocking their energies, for them to become the primary drivers of renewal and change and changing the culture of the public service so that we treat citizens with dignity and serve the people with compassion and professionalism.

The tabling of the budget marked the end of a process of consultations including izimbizo that were held in many parts of the municipality with members of the public and other interested stakeholders.



ort Napier and its imperial garrison was one of the most significant institutions in Pietermaritzburg and indeed in the whole country.


It was established on August 31, 1843 to house the British garrison in Natal after the area was annexed by Britain and became the Colony of Natal. The 45th Regiment initially provided the garrison but many other regiments took their turn and the fort was an extremely important base for the British during the Anglo Zulu War of 1879 and during the two Anglo Boer Wars.

The last British troops left the fort in 1914 and it was used as an internment camp for German nationals during WWI. In the 1920's the fort

became known as the Fort Napier Psychiatric Hospital, and continues to serve the same function today despite the name changes to Town Hill Mental Hospital and now Fort Napier Hospital.

Still standing today among the original structures in the complex area brick water tower, a recreation hall and the lovely wood and iron garrison officer's mess. Adjacent to the fort is St George's Garrison Church that was built in 1893 for the garrison to have somewhere close by to worship. It was used as a hospital during the Second Anglo Boer War.
