The Msunduzi Municipality (Roads and Transportation Unit) will be embarking on an extensive roads and storm-water related construction projects for various grant funded projects set to commence in the next financial year 2015/2016. As a result, the Municipality invites suitably qualified and experienced Contractors with a CIDB grade of 2CE or higher to clearly detail their experience in relation to roads and storm-water on forms that will be provided by the Municipality.

These forms (Curricula Vitae) will be used to select suitable qualified contractors who will be invited to participate in a closed tender process in terms of Clause 36 of the Municipality's Supply Chain Management Policy on an as and when required basis. The Contract for pre-qualification of contractors shall span for a period of two (2) financial years commencing from date of award and terminating on the 30 June 2017.

Tenderers will be classified in terms of their CIDB grading and only tenderers with the CIDB grading corresponding or higher to the one required for that specific project will be invited to participate in the closed tender process. The work, as far as practical as possible, will be distributed on a rotational basis in order to allow for an even distribution of the work.

To this end, the Municipality hereby invites suitably qualified and experienced Contractors with a CIDB grading of 2CE or higher to detail their experience on Registration Forms provided by the Municipality. - CK 1 & CK 2 forms for close Corporations, CM (3) documents for PTY or PTY (Ltd) companies, certified Copy of ID document for Sole Proprietor, copy of Partnership Agreement for Partnerships and copy of Trust Document for Trusts
- Original valid TAX clearance Certificate obtained from SARS
- Valid proof of their CIDB Grading
- Curriculum Vitae of all skilled personnel including certified copies of their qualifications
- Details of all road construction projects successfully completed together with bone fide contact details of all referees.
- Schedule of plant and equipment owned by the Contractor.
- Bank rating

The works to be carried out under this contract entails the construction or upgrading of roads from gravel to surfaced roads with associated storm-water within Msunduzi Municipality.

The works generally comprise:

- Clearing and grubbing of the road reserve area before and after.
- Removing and reinstating of existing fences and reallocation of existing services
- Construction of storm water management systems, concrete channels, kerbs and installation of pipes, etc.
- Excavation for road layerworks.
- Rip and re-compact insitu material for roadbed preparation.

- Importation of suitable material for road formation and layers, in sections where road widening is proposed.
- Construction of road layer works e.g. G7, G5, G2, etc.
- Construction of sub-soil drain.
- Surfacing of road with asphalt or concrete.
