Application for a rebate in terms of Section 21 of the Msunduzi Rates Policy and Section of the Msunduzi Policy in respect of Properties Owned and Occupied by the Registered owner whose ONLY source of income is a State Pension or State Welfare Grant.

NB Rebates for 2020/2021 close on the 31st May 2020 and queries must be resolved prior to the 30th September 2020.

- 1. This application must be completed in full and CERTIFIED COPIES of the following documents must be attached:
 - I. Identity Document(s) all owners / part owners
 - II. Proof of Grant from 390 Pietermaritz Street or Civic Centre Northdale **OR** proof of private pension.
 - III. Proof of all additional income, from all owners, from all sources.
 - IV. 3 months' current bank statements of all bank accounts.
 - V. Proof of unemployment from Department of Labour.
- 2. Rebates will only be implemented 30 days following the date of the application of all documentation being submitted correctly. Applications are only valid for the appropriate financial year and shall lapse at the end of that year. If no new application is received before the expiry date, normal tariffs will be due and payable.
- 3. Pensioners must be 60 years or older to qualify for the rebate.
- 4. The rebate is subject to the following conditions:
 - I. Applicant(s) must be the OWNER and OCCUPIER of the premises as at 1st July 2020.
 - II. The total income of the APPLICANTS, SPOUSES and ALL OCCUPANTS FROM ALL SOURCES must not exceed the amount approved by the Msunduzi Municipality per month.
 - III. There should be ONE DWELLING ONLY on the property.
 - IV. There should be one electricity meter and one water meter only on the property.
 - V. Applicants may not own more than one property (including vacant land) either nationally or internationally.
 - VI. In the case of joint ownership, all owners must meet the criteria.
 - VII. The FINANCE BUSINESS UNIT must be notified immediately of any CHANGE IN CIRCUMSTANCES.
 - VIII. Rebates must be applied for annually.
 - IX. No rebate will be granted to any pensioner or grantee whose rates and/or services account is in arrears unless a valid arrangement is in place and is being maintained. The rebate will be terminated if any default to an arrangement occurs.
 - X. All other Council conditions for rebates will apply.
