Bearman makes waves after debut with Ferrari

Ferrari's teenage rookie Oliver Bearman (pictured) finished an impressive seventh on his Formula One debut at the Saudi Arabian Grand Prix on Saturday with former world champion Damon Hill proclaiming: "A star is born".

The 18-year-old Briton was only told he was replacing appendicitis victim Carlos Sainz on Friday morning but drove with the cool aplomb of a seasoned campaigner to score points in his first outing — and after only one practice ses-

"Star is born now." 1996 world champion Hill wrote on X.

"To jump in at such short notice, on a track as intimidating as Jeddah, in a Ferrari of all things, and hold up under immense pressure and keep it together ... Wow." Seven-time champion Lewis Hamilton, who

finished ninth for Mercedes in a race won easily by three-time champion Max Verstappen ahead of his Red Bull teammate Sergio Perez, applauded his young compatriot from his cockpit on his slow-down lap. Team bosses and rival drivers followed with

warm words for Bearman, who is not only the youngest driver in Ferrari's F1 history, but the voungest Briton to race in the sport. He was also the third youngest of all time be-

hind Lance Stroll and Verstappen.

"I'm a little tired," said Bearman. "As you can see, I don't look my best! It was a fantastic race, pushing all the way. I was shocked at how fast we were pushing, getting quicker every lap.

Luka Doncic makes NBA history

Dallas star Luka Doncic (pictured) grabbed a slice of NBA history on Saturday, becoming the first player to post six straight 30-point triple-doubles as the Mavericks beat the Detroit Pistons 142-124.

Doncic scored 39 points with 10 rebounds and 10 assists, eclipsing Russell Westbrook's mark of five straight 30-point triple-doubles set in the 2016-17 season.

The Slovenian star extended his own NBA record with a fifth straight triple-double featuring 35 or more points. He added three steals and a pair of blocked shots for good measure.

"That just shows where he's playing at right now," said Mavericks coach Jason Kidd, who has called Doncic's run of form "as rare as Picasso".

"It's the level that he's at, to be able to score and also to be able to find his teammates and then, lastly, being able to rebound the ball for us to

help us on the defensive end," Kidd said. Doncic scored 26 points in a back-and-forth first half. That included 21 in the second quarter, when Doncic appeared to be galvanised by chants

of "Luka Sucks" from Pistons fans. "Well, we know he doesn't suck," Kidd said. "I think we know he enjoys when people talk to him. If that's what sparked him, we would like for that

to happen a lot more." Kyrie Irving added 21 points for Dallas, who pushed their lead to 16 points in the third quarter

and opened the fourth on a 7-0 scoring run.

Cade Cunningham scored 33 points with 10 assists and nine rebounds for the Pistons. But it was another night of frustration for Detroit and it boiled over in the fourth when

Jalen Duren was ejected for a hard shove of P.J. Washington.

Washington had nudged Duren aside to help up teammate Daniel Gafford after Duren had fouled him under the basket

The league-leading Boston Celtics avoided their first three-game losing streak of the season with a 117-107 victory over Kevin Durant and the Suns in

Phoenix. Jayson Tatum shook off a slow start to score 29

points and grab 10 rebounds. Jaylen Brown added 27 points for Boston, who were coming off losses to Cleveland and reigning NBA champions Denver.
