TERMS AND CONDITIONS

1.1 The Msunduzi Municipality's Standard Conditions of Tender, Legislation Section, Special Conditions of Contract (if any), Supply Chain Management Policy and the Preferential Procurement Policy shall also apply. The above-mentioned documentation may be inspected at the offices of the Head: Supply Chain Management, 5th Floor, A S Chetty Building, 333 Church Street, Pietermaritzburg.

1.2 Further to the above, the following terms and conditions shall also apply: -

- a) Where in the tender document reference is made to a compulsory Site Inspection/Tender Briefing Meeting, the Tenderer shall be required to attend the Meeting prompt on the date and time mentioned in the tender document. Tenderers arriving at the meeting after the stipulated time **WILL BE DISQUALIFIED** and the Council shall not be held liable for any loss or damage due to the above. Tenderers are to ensure that they sign the Attendance Register circulated at the meeting and to also ensure that the Site Inspection/Tender Briefing Certificate attached hereto is duly signed by the authorised official.

An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Tenders will not be considered from Tenderers who do not attend the meeting and whose Site Inspection/Tender Briefing Certificate has not been commissioned by the authorised official. ***Tenderers shall be required to present the tender document at the meeting.***

- b) It is a condition of tender that the taxes of the successful tenderer must be in order, or that satisfactory arrangements have been made with the South African Revenue Service (SARS) to meet the tenderer's tax obligations.

Service Providers shall be required to submit, together with the tender document, a valid Tax Clearance Certificate and a Tax Compliance Status Verification Pin issued by SARS. Failure to submit a valid Tax Clearance Certificate and a Tax Compliance Status Verification Pin, the Council reserves the right to verify the same on National Treasury's Central Supplier's Database.

Further to the above, Service Providers are to note that the Tax Clearance Certificate must be valid for the full duration of the tender validity period i.e. three (3) months commencing from the closing date of the tender.

Should the validity of the Tax Clearance Certificate expire prior to the final award of the

contract being made, the Council reserves the right to request the Service Provider to submit a further valid Tax Clearance Certificate. In this instance, the Service Provider shall be given seven (7) working days written notice in which to comply. Should the Service Provider fail to comply with this request, the Council further reserves the right to make no award to the Service Provider and the Council shall not be held liable for any loss or damages sustained by the Service Provider.

If a Service Provider has already submitted an original Tax Clearance Certificate when registering on the Central Supplier Database (CSD), then there is no need to submit a hardcopy of another Tax Clearance Certificate provided that the Tax Clearance Certificate is still valid for the full duration of the validity period for this tender. In this instance, the Service Provider will be required to indicate below the CSD Supplier Number and Unique Registration Reference Number for verification purposes: -

- c) The prices, rates or percentages quoted in the proposal shall be deemed to include all costs, including but not limited to materials, plant, labour, patent rights and royalties, freight, insurance, customs, railage, delivery, etc., unless the Service Provider states otherwise on Annexure A hereto.
- d) Tenders must be made out on the Tender Form annexed hereto. Service Providers are advised that this document must be completed by being hand written and submitted in its entirety. Failure to comply with this condition shall result in the tender being disqualified.

Service Providers must complete the following **Data Sheets, Declarations of Interest, Authority to Sign, Pricing schedule, Declaration of bidders past supply chain management practises, Certificate of independent bid determination and the Tender Form** and any other applicable data sheets attached hereto in their entirety for adjudication purposes. Where Data Sheets and/or any other documentation as contained herein are required to be commissioned, such Data Sheets and/or documentation must be stamped and signed by a Commissioner of Oaths (where applicable).

Failure to comply with these provisions will render the offer unresponsive (invalid).

- e) Only original hand priced tender documents will be considered. Tenders submitted by telegram, telex or facsimile shall not be considered. ***The use of correction fluid is strictly prohibited.*** All corrections are to be countersigned.
- f) Where compliance with CIDB Regulations are required, only those Tenderers who meet the required grading mentioned herein or higher or whose status is active at the time of tender shall be considered for appointment. In this instance, Tenderers shall be required to indicate in their tender document their CIDB Registration No. for adjudication purposes. ***Failure to comply with these conditions will prejudice the tender.***
- g) With regards to electrical works, only Tenderers who are registered with the Electrical Contractors Board (ECB) shall be considered for appointment. In this instance, certified proof of such registration must be submitted together with the tender for adjudication purposes. ***Failure to comply with these conditions will prejudice the tender.***
With regards to plumbing works, only Tenderers who are registered with the Institute of

Plumbing South Africa (IOPSA) or any other relevant authority shall be considered for appointment. In this instance, certified proof of such registration must be submitted together with the tender for adjudication purposes. ***Failure to comply with these conditions will prejudice the tender.***

- h) Tenderers should propose a detailed implementation plan for the completion of works and the production of deliverables. The following framework should serve as a rough guide for the preparation of tenders:
- Background of the Contractor;
 - Experience and capacity relevant for the project;
 - Overall management of the project in terms of personnel;
 - Approach and understanding of the project requirements;
 - Implementation plan to achieve the objectives within the required time frame;
 - Phasing of tasks, deliverables and reports for the project; and,

Curriculum Vitae for all proposed professional personnel on the project should include biographic data, educational qualifications and experience.

Tenderers may assume any number of forms including but not restricted to a consortium/joint venture that draws on multiple disciplines, practices and experiences.

It is also strongly recommended that in selecting their partners, consortia consider “smaller” but capable organizations, which, while strengthening the proposal, will also receive some developmental benefit from partnering with larger organizations. In the event the selected proposal is a consortium/joint venture, the contract will be signed with the lead organization, which must be identified in the proposal.

- i) Proposals are to be formulated using efficiency, effectiveness, economy and sustainability as a basis.
- j) Tenderers shall be required to detail their experience applicable to the works mentioned herein in Data Sheet 1 – Statement of Previous Experience for adjudication purposes.
- k) In the event of late delivery, penalties in the amount of R500.00 per calendar day shall be levied. Such monies shall be deducted from any monies due to the Contractor or which shall become due to the Contractor.
- l) Tenderers claiming preference points shall be required to complete Annexure “C” hereto in its entirety and to fully comply with the General Conditions, Definitions and Directives stated therein. Failure to do so shall result in no preference points being awarded to the Tenderer and the Council shall not be held liable for any loss or damages in this regard.

In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender.

Tenderers are required to submit, together with the tender document, proof or documentation required in terms of this tender to claim points for specific goals with the bid, will be interpreted to mean that preference points for specific goals are not claimed. Partial awards may be made where this is perceived by the Head: Supply Chain Management to be in the best interests of the Council.

The council reserves the right but is not obliged to take into account the principle of the distribution of work in order to empower SMME'S and BEE'S. Such distribution may take place with reference to items, sections as indicated in the price schedule or such other bases the council may decide.

The Council does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or any part of a tender.

- m) Payment will be made by the Chief Financial Officer within 30 days on receipt of a certificate of payment issued by the Engineer and will be made by means of a cheque drawn upon the Council's bankers in Pietermaritzburg. No cash payments shall be made.

Where the value of the works exceeds R3 000.00 excluding VAT, the Tenderer must quote the Council's VAT Registration No. (460 010 783 5) on all Tax Invoices for payment purposes.

Where offers of discounts, e.g. for payment within 30 days of rendering accounts, are made by Contractor, these will be taken into account in the adjudication of tenders.

Tenderers shall be required to have a bank account in the legal name of the Tenderer as indicated on the Tax Clearance Certificate. No payment whatsoever will be made should the Tenderer fail to comply with this requirement and the Council shall not be held liable for any loss or damages sustained by the Tenderer in this regard.

- n) Where Insurances or any other information as requested for in the tender are required, the Tenderer shall submit such Insurances and/or information within fourteen (14) days from date of letter of provisional acceptance. In cases of Insurances, these are to be kept in force for the full duration of the contract period.
- o) Once the requirements of the provisional letter of acceptance have been satisfied, a final letter of acceptance will be forwarded by the Head: Supply Chain Management to the Tenderer and the tender, provisional letter of acceptance together with the final letter of acceptance shall constitute a binding agreement between the Tenderer and the Council.
- p) If the Tenderer fails to enter a contract when called upon to do so, then the Council may refuse to receive or consider for such period as it may think fit, any further tenders from that tenderer.
- q) Where awards of contracts are not subject to (p) above, a final letter of acceptance will be forwarded by the Head: Supply Chain Management to the Tenderer and the tender together with the final letter of acceptance shall constitute a binding agreement between the Tenderer and the Council.
- r) In the event of a presentation being required, all costs arising from such presentations shall be borne by the Tenderer.
- s) In the event of samples being required, all samples supplied shall be at no extra cost to Council. The onus shall rest with the Tenderer for the removal of the same. No liability for damages shall be accepted whilst samples are on Council's premises.

- t) The onus rests with the Tenderer to ensure the safekeeping of all property belonging to the Tenderer whilst working on Council's sites as no claims for any loss or damages will be entertained.
- u) Unless otherwise specified in these documents, the Tenderer shall state the period within which the complete delivery of all items described in these tender documents and covered by this contract is offered. Such period(s) shall form part of the Conditions of Contract and may be taken into consideration in the adjudication of tenders.
- v) If a Tenderer wishes to submit alternative proposals for consideration or wishes to change the Conditions of Contract, Specification, Quantities or Drawing, or to qualify the tender in any way, such changes and or proposals are to be listed in Annexure "A" hereto, failing which the tender will be deemed to be unqualified. The National Treasury's Central Supplier Database (CSD) has been open for registration from 01 September 2015. The CSD serves as one single source of supplier information to all spheres of government.

Within this system, suppliers are required to register once when they do business with the state. This will significantly reduce the administrative burden for businesses, especially small and medium sized enterprises. The database interfaces with the South African Revenue Service (SARS), the Companies and Intellectual Property Commission (CIPC) and the payroll system. It will electronically verify a supplier's tax status and enable public sector officials doing business with the state to be identified.

SPECIFICATIONS

1. SCOPE OF WORKS

- 1.1 The contract calls for a service provider to provide the required items as per detail specification below.

2. DETAILED SPECIFICATION AND FEATURES

2.1 ITEM INSPECTION

- 2.1.1. Supply, delivery, installation of Emergency Warning Lights and Sirens.
- 2.1.2. This system must be issued with certificate, from an approved installer by the supplier to the end user, when the equipment is supplied and installed. The successful bidder may be requested to submit equipment to an inspecting or standard-setting authority, to confirm compliance with certification.
- 2.1.3. Installers, approved by suppliers, must be capable of removing and re-installing the equipment onto similar vehicle, when the original vehicle is no longer used.
- 2.1.4. All components of the system must work and function as one system (unit). All equipment must comply with the vehicle manufacturer's specification and not interfere or hamper with functionality of the vehicle. This equipment shall provide a turnkey solution for the intended use thereof.
- 2.1.5. **ALL BIDDERS MUST BE THE PRINCIPAL MANUFACTURER / IMPORTER OR REGISTERED AGENT/ DISTRIBUTOR.**
Proof as Agent / Distributor / Importer / Manufacturer must be submitted with bid document.
- 2.1.6. Holes to be drilled into vehicles roof or body for installation needs to be concealed. Bidders must indicate how they intend to mount equipment and channel wiring without resulting in water dripping or leaking through door openings and rubbers. In the event that holes need to be drilled, the bidder shall provide a comprehensive description on how these holes can be sealed in future once lights are removed. (This is applicable to all equipment discussed in this document).
- 2.1.7. **NOTE: Generation-5 and Generation-3 LED:** In the specification, generation-5 & 3 LED refers to the industry standard.
- 2.1.8. The light bar electronic circuits must be protected against water or moisture penetration.
- 2.1.9. The units must comply in all respects with the requirements of the follows.

2.2 EMERGENCY LIGHT BAR WITH BUILT-IN SPEAKER

- 2.2.1. The light bar shall be fully enclosed, that is there shall be an outer lens and all light bar components and parts shall be mounted in the light bar and behind the outer lens and be a minimum generation 3-5 LED light-bar.
- 2.2.2. Shall be 1.2m in length.
- 2.2.3. Shall be aerodynamic in cross section to reduce drag to a minimum.
- 2.2.4. The full-length light bar shall be of robust construction capable of being mounted on the roof of any standard vehicle.
- 2.2.5. Shall be supplied with all mounting brackets and all accessories needed for installation onto all types of vehicles.
- 2.2.6. The feet of the light-bar shall be robust, rust resistant and designed in such a manner as to neither cause damage to the roof of the vehicle nor cause any vibration.
- 2.2.7. Shall have an extruded aluminium top and bottom chassis.
- 2.2.8. Shall have glass filled nylon or polycarbonate speaker horn mounted on top of the light bar with full forward sound projection.
- 2.2.9. Shall have built-in 100watt speaker driver mounted inside the light bar.
- 2.2.10. Lenses and lens connectors shall be manufactured from polycarbonate material having a high impact and temperature resistance. Proof of the materials used in the form of a certification letter, must be provided by the manufacturer of the lenses, and shall be submitted with the sample of the light bar.
- 2.2.11. Shall have ultraviolet stabilizers used in the pigment to prevent fading and degradation.
- 2.2.12. The front, sides and back outer lenses of the light bar shall be blue in colour. The lenses in front of additional LED's shall match the colour of the emitting LED's.
- 2.2.13. Shall have a minimum of 14 LED modules.
- 2.2.14. All LED modules to be a minimum generation 3-5 as to each LED to be a minimum of 1-3watt.
- 2.2.15. Each LED module shall comprise of a minimum number of six (6) LED's, except the corner LED modules which shall comprise a minimum number of three (3) LED's,
- 2.2.16. The 14 LED modules shall emit the following colours when switched on:
- 2.2.17. The 14 LED modules shall be positioned and located in the light bar as follows:
 - i. Minimum four (4) LED modules (blue), facing the front.
 - ii. Minimum four (4) LED modules (blue), facing the rear.
 - iii. Three (3) LED modules (blue) shall be on each side (one per side shall be angled at 45° to the rear, one per side shall be at 90° facing outwards and one per side angled at 45° to the front)
- 2.2.18. The outer front and rear LED modules and all side LED modules must also function as cruise lights. The cruise lights must utilise 80% of the power output of the LED module.
- 2.2.19. Light emitted from the LED's shall be even across 360 degrees of the entire light bar, maximum visibility at all angles.
- 2.2.20. Shall have supply voltage of 10 - 30v DC $\pm 10\%$, with maximum current draw of 6 amps at full function mode.
- 2.2.21. **Power and communication cables between the power source and the control switch unit, shall be supplied, all cables enclosed in a proper wiring harness.**
- 2.2.22. **Shall have a minimum guarantee of 02 years on all components including Workmanship as per normal wear and tear.**

2.3 INTEGRATED P.A. SIREN WITH SWITCH PANEL

- 2.3.1. The control switch panel is designed to allow the operator to quickly activate equipment associated with emergency response situations.
- 2.3.2. All equipment mentioned in this specification must interface with the control switch unit.
- 2.3.3. Shall provide a flexible and intuitive interface between the driver and the vehicles emergency response equipment.
- 2.3.4. Apart from all switches, the Hand Control switch panel shall have one master switch plus customer-programmable switches and P.A volume switches.
- 2.3.5. The hand controller shall have an integral PA microphone with a 'push-to-talk function (PTT) allowing connection to the siren amplifiers is essential.
- 2.3.6. Shall have supply voltage of 13.2v or 24v DC $\pm$ 10%.
- 2.3.7. Shall have an integrated headlight flasher (giz-wag) function if required.
- 2.3.8. Shall have auxiliary output for additional warning equipment.
- 2.3.9. Shall control the LED full-length light bar, integrated siren, PA, headlight flasher, and auxiliary output.
- 2.3.10. The switch panel controller unit shall have visual identification with no protruding switches and backlighting to indicate which lights are selected and indicates the status of the siren and PA system.
- 2.3.11. The control switch panel shall have switches to activate or turn on the following:
 - i. One master switch shall activate and turn on all lights in the light bar, siren system and additionally fitted emergency lights.
 - ii. One switch shall activate and turn on the blue cruise lights.
 - iii. One switch shall activate 50% dimming on light bar for night time use.
 - iv. One switch shall activate and turn on the lights to the front and side of the light bar and all additional emergency lights.
 - v. One switch shall activate and turn on the lights to the rear and side of the light bar and all additional emergency lights.
 - vi. One momentary switch to step through Wail, Yelp and Phaser tones.
 - vii. One switch shall activate and de-activate two-way radio broadcast via PA system.
 - viii. One switch shall activate the integrated Headlight flasher function.
 - ix. Two switches shall set P.A volume up or down when activated.
- 2.3.12. Should be plug and play type (if faulty controller must be removed and replaced).
- 2.3.13. The user shall have full control over the front, rear and side modules of the light bar.
- 2.3.14. Must have a coiled cable, for cable to minimise interference from portable radios.

2.4 SIREN AND PA SYSTEM – INTEGRATED WITH LIGHT-BAR

- 2.4.1. Must be a rugged 100-WATT, electronically controlled siren and public address (PA) system.
- 2.4.2. The unit shall be supplied with all necessary cabling and other hardware required for installation.
- 2.4.3. The 100watt speaker must be mounted inside the light bar and project sound in a forward motion.
- 2.4.4. The system shall function with a single 100-watt speaker driver; the speaker shall be of a slim-line design for a minimum space intrusion.
- 2.4.5. The unit shall be a single amplifier that has remote capabilities that can be remotely activated from the control switch unit.

- 2.4.6. The operational requirements of the end user requires the unit to have an override facility to allow the integrated public address function to be used in the siren mode. Pressing the push-to-talk switch shall cause the public address mode to override the siren mode. Releasing the push-to-talk switch shall result in automatic reversion to normal operation within 500ms. The public address function shall however, be able to function independently from the siren function.
- 2.4.7. Radio broadcast is required to allow for a two-way radio broadcast through the PA system.
- 2.4.8. The unit shall have a control to allow adjustment of the PA sound level.
- 2.4.9. The systems must be able to integrate with the vehicle horn circuit, to provide the following functions:
 - i. Toggle between Wail and Yelp tones ii. Selection of other tones. iii. Switch on both the siren tone and emergency lights when immediate response is essential.
- 2.4.10. When no siren tone is selected, the horn of the vehicle shall activate the siren amplifier air-horn tone.
- 2.4.11. The yelp and wail tones shall be as defined in the National Road Traffic Act.
