**SALE OF FOUR (4) REDUNTANT SOLID STEEL WEIGHBRIDGES AT THE

The Msunduzi Municipality hereby invites Tenderers to submit offers for the sale of four (4) redundant solid steel weighbridges at the New England landfill site.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A. S. Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00** on **Wednesday, 14 November 2012**. A non-refundable tender fee in the amount **R 119.70** (Including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

*A **compulsory Site Meeting** will be held on **Tuesday, 20 November 2012**. Prospective tenderers shall meet at **10h00 prompt**, New England Road Landfill Site, New England Road (Opposite Hayfields Golf Course), Pietermaritzburg. Only one Site Meeting will be held. No tender shall be accepted from tenderers who do not attend the above meeting.*

Sealed tenders, endorsed on the envelope "**QUOTATION No. SCM Q37 OF 12/13**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00**, on **Friday, 23 November 2012**, when it will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

The Validity period shall hold firm for ninety (90) days commencing from closing date of the tender.

Tender Adjudication & Evaluation Criteria will be implemented in line with the Msunduzi Municipality's approved Supply Chain and Preferential Procurement Policies on the **80/20** point system. Adjudication criteria will be as per the tender document, the allocation of points will be in line with **B-BBEE** as prescribed in terms of the Preferential Procurement Regulations, 2011 pertaining to the **Preferential Procurement Policy Framework Act**, Act No. 5 of 2000.

The Msunduzi Municipality does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or any part of a tender. Each Service Provider will be informed of the tender result.
