Tender Adjudication & Evaluation Criteria will be implemented in accordance with the Msunduzi Municipality's Supply Chain Management Policy (incorporating Preferential Procurement) on the 80/20-point system. Adjudication criteria will be as per the tender document, the allocation of points will be in line with specific goals as prescribed in terms of the Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.
