Thereafter **all prospective tenderers will proceed in convey to site**. Only one Tender Briefing/Site Inspection Meeting will be held. An official will chair the meeting and answer any queries raised by prospective tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. ***No tender shall be accepted from tenderers who do not attend the above meeting.***

Sealed tenders endorsed on the envelope "**QUOTATION No. SCM Q98 of 12/13**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00**, on **Wednesday, 24 April 2013**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Shall hold firm for ninety (90) days commencing from the closing date of tender.
