IF THE AUTHORITY FOR THE ERECTION AND DISPLAY OF THE SIGN IS GRANTED BY THE MUNICIPALITY, THE APPLICANT AGREES THAT HE/SHE SHALL BE BOUND BY THE FOLLOWING CONDITIONS:

Any person who displays or causes any board to be displayed on any municipal property, shall comply with the following requirements:

- 1. Such board shall only be used for the purposes of indicating the route to the property or premises lo be sold or advertised and shall only be erected on the days on which the property is to be shown.
- 2. Such board shall not exceed 0,6m2 in area, not more than 2 per site at the same time.
- 3. Such boards shall not to be positioned so as to hinder or obstruct a pedestrian's right of way on a sidewalk or to unfairly prejudice traders.
- 4. Only one such board per street frontage, per enterprise, shall be allowed to advertise services and such board shall be placed directly in front of the advertised premises.
- 5. Applicants shall be required to indemnify the Municipality against any claims that may arise from the placement of such signs within the road reserve or on municipal property and shall be required to procure third party insurance for this purpose.
- 6. Mandate from Land lord needs to be submitted to the signage department, which states that the owner of the property has granted you permission to advertise on their behalf. (Before erection of any structure)
- 7. If the sign erected and displayed by the applicant differs materially from the information supplied in this application, or is not erected in the proper location, the Municipality's authority shall be withdrawn and the Municipality shall be entitled to remove the sign at the applicant's cost.
- 8. There shall be no obligation upon the Municipality to refund to the applicant any fee in accordance with these conditions if the Municipality's authority lapses or is withdrawn or a client withdraw for any reason whatsoever.
- 9. The sign shall be erected and displayed at the applicant's risk and he hereby indemnifies the Municipality against any claims which may be made against it for any loss, damage, injury or death suffered by any person arising directly or indirectly out of the erection, existence, use, maintenance, repair or removal of the sign and the applicants shall reimburse the Municipality any cost incurred by it in defending any such claim.
