#### **RESPONSE TO ENQUIRIES RAISED BY POTENTIAL TENDERERS**

The aspects listed below were raised by potential tenderers in response to the Tender Notice outlining the above contract as publically advertised on 20 August 2020.

1. Are we able to bid only on the sanitizer portion of this contract?

#### ***MSUNDUZI MUNICIPALITY RESPONSE***

*This is an itemised bid, which means we are going to award it per item.*

2. I believe the above tender calls for handheld IR thermometers. May I kindly ask that you reply with the tester docs?

#### ***MSUNDUZI MUNICIPALITY RESPONSE***

*There is no tester docs for the thermometer that we want to procure. Kindly submit your bid doc, sample and an offer for that it.*

3. Please clarify the amount of mask your require for the surgical one. You asking for 120000 unit but specify 50 in a box. Do you need 120 000 boxes or 120 000 single mask. 120 000 mask makes up 2400 boxes of 50 in a box.

#### ***MSUNDUZI MUNICIPALITY RESPONSE***

*It should be noted that these quantities are estimates and they do not represent the real quantities to be purchased per year. Our estimates is that we will buy 10 000 units per month which equates to 120 000 per year (200x50boxes)*

10. Please assist if at all possible, we as a company are Level 4 Bee, are we able to attempt to quote on face shields for the above tender for I did notice in the qualifying Criteria that u specify Level 1.

If I am bidding for gowns, I should submit 1 Gown as a sample?

For sanitisers I should submit 1 x 5l of water based sanitiser, 1 x 5l of gel-based sanitisers as well as 1 x 500ml gel sanitiser as samples.

- Should we submit a proof of auditing process from the SABS?
- Are the samples to be submitted before the closing date?
- Would be considered for the if we only bid for what we are manufacturing i.e. surgical gowns, overshoe covers, fabric cloth masks.
