9. N.B. POSTERS TO BE PLACED ONLY ON LIGHT POLES. No posters may be displayed on robots, trees, walls or street furniture and within the surrounding perimeter of the City Hall.

#### 10. SUBMISSION REQUIREMENTS:

- 10.1 Application form
- 10.2 Application fees as prescribed in the signs bylaws.
- 10.3 Proof of payment
- 10.4 Copy of a proposed advertisement should be submitted for approval

Any False or misleading information supplied by the applicant will render the applicant liable for prosecution.

#### 11 POSTER REQUIREMENTS

- 11.1 Maximum of 15 bits (content), Maximum size A1
- 11.2 Logo/Picture (subject to council approval)
- 11.3 Name of event (lettering height of 5cm/50mm
- 11.4 Date, Time and Venue
- 11.5 Sponsors logo (heights shall not be more tan 2cm/20mm)
- 11.6 Sticker allocation space (white block, 5.5cm (h) x 4.5cm bottom right corner )

#### 12. **DECLARATIONS:**

IF THE AUTHORITY FOR THE ERECTION AND DISPLAY OF THE SIGN IS GRANTED BY THE MUNICIPALITY, THE APPLICANT AGREES THAT HE/SHE SHALL BE BOUND BY THE FOLLOWING CONDITIONS:

- 12.1 The authority shall be for a short term period and subject to these conditions and shall lapse 3 days after the event.
- 12.2 If the sign erected and displayed by the applicant differs materially from the information supplied in this application, or is not erected in the proper location, the Municipality's authority shall be withdrawn and the Municipality shall be entitled to remove the sign at the applicant's cost.
- 12.3 Upon the lapse of the Municipality's authority for whatever reason, the applicant shall remove the poster and make good the site to the satisfaction of the Municipality.
- 12.4 The poster should be erected 14 days prior to the event and is limited to one pole per poster
- 12.5 If the applicant does not remove the sign upon the lapse or withdrawal of the Municipality's authority, or if he fails to make good the site to the satisfaction of the Municipality, the Municipality may itself remove the sign or make good the site and any cost incurred thereby shall be recovered from the applicant.
- 12.6 There shall be no obligation upon the Municipality to refund to the applicant any fee in accordance with these conditions if the Municipality's authority lapses or is withdrawn or a client withdraw for any reason whatsoever
- 12.7 The sign shall be erected and displayed at the applicant's risk and he hereby indemnifies the Municipality against any claims which may be made against it for any loss, damage, injury or death 3suffered by any person arising directly or indirectly out of the erection, existence, use, maintenance, repair or removal of the sign and the applicants shall reimburse the Municipality any cost incurred by it in defending any such claim.
