- (c) who is an advisor or consultant contracted with the municipality or municipal entity.”*



You are expressly advised that any award in contravention of the above would be in direct conflict with the aforesaid Legislation and shall be deemed void and without any legal effect.

Furthermore, this award is made on the understanding, condition and agreement that you undertake to indemnify and hold the Municipality harmless against any and all claims and demands from any Third Party whatsoever arising from or related to any award in contravention of the aforesaid regulations.

It must be noted that this Letter does not constitute an official Order. Your Company is to only effect delivery of any works once in possession of an official Order issued by the Msunduzi Municipality.
