#### UPGRADING OF NEW ENGLAND LANDFILL SITE, PIETERMARITZBURG

The Msunduzi Municipality hereby invites tenders for the following works at the New England Landfill Site:-

1. Construction of containment berms,
2. Upgrades to leachate pumping system,
3. Supply and erect concrete palisade fencing,
4. Clay-capping of containment berms, and,
5. Upgrading of access ramps to the Site

**Only tenderers with a CIDB Contractor grading of 5CE PE or higher, who have the relevant expertise, capacity, experience and/or construction equipment shall be eligible to submit tenders.**

Tender documents shall be available from the Supply Chain Management Unit Offices, 5<sup>th</sup> Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Monday 26 August 2013**. A non - refundable tender fee in the amount **R633.84** (including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Clarification Meeting will take place at 10h00 on **Thursday, 5 September 2013** at the New England Road Landfill Site, New England Road, Pietermaritzburg. Prospective Tenderers shall be required to meet promptly at the said time in the New England Road Landfill Site's Boardroom from where all will travel in conveyance to the various workplaces. Only one compulsory Clarification Meeting will be held. ***Tenderers arriving at the meeting after the stipulated starting time will be disqualified.*** An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. ***All Tenderers attending the meeting must be in possession of a tender document.***

Sealed tenders in accordance with the Conditions of Tender and Tender Data and endorsed on the envelope "**Contract No. SCM 13 of 13/14**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00, on Friday 13 September 2013**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Ninety (90) days commencing from the closing date of tender.

**Tender Evaluation Criteria:** The tender shall be evaluated on the 90/10 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.

The Msunduzi Municipality does not bind itself to accept the lowest or any tender, and reserves the right to accept the whole or any part of a tender. Each tenderer will be informed of the tender result. The Msunduzi Municipality expects businesses within the Pietermaritzburg and Midlands Region to support its contract and BEE/SMME initiatives.
