Tenders are invited from suitably qualified and experienced Tenderers who have a **CIDB Contractor Grading of 6 CE PE or higher** to submit tenders for the following works:-

- Upgrading of 1,4km of New England Road and 0,25km of Murray Road;
- Construction of 0,42km of internal cemetery road and storm water drainage;
- Construction of two vehicular parking areas (approximately 190m² each);
- Construction of public ablution blocks facilities;
- Conversion of two existing houses into offices, store rooms and a Chapel;
- Construction of perimeter fencing and access control, and,
- Installation of electrical lighting within the project area.

A **compulsory Tender Briefing Meeting** will be held at **10h00 prompt on Friday, 19 October 2012**, in the EXCO Boardroom, 4th Floor, A. S. Chetty Building, 333 Church Street, Pietermaritzburg. Tenderers are advised that after the said meeting, all parties concerned shall be required to travel in convoy to the above site. Tenderers who do not attend the Tender Briefing Meeting will not be considered for appointment. No tender documentation whatsoever will be signed on site. Only one compulsory Clarification Meeting will be held. An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's Attendance Register. Tenderers will be required to present their tender document at the Clarification Meeting.

Sealed tenders endorsed on the envelope "**Specialised Contract No. SCM 17 of 12/13**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, 3201, not later than **12h00 on Thursday, 5 November 2012**, when they will be opened in public. Only tenders placed in the tender box shall be accepted. Under no circumstances whatsoever will any extension of time be allowed for submission of tenders.

Tender Validity period: Three (3) months commencing from the closing date of the tender.

Tender Adjudication/Evaluation Criteria: The tender shall be evaluated on the 90/10 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.
