Prospective tenderers shall meet at the Engen Service Station (opposite Hulamin), Selby Msimang Road (Edendale Road), Edendale, at 10h00 prompt and thereafter proceed in convoy to site. No transport will be provided. Only one Site/Clarification Meeting will be held. No tender shall be accepted from tenderers who do not attend the above meeting.

An official will chair the meeting and answer queries raised by prospective Service Providers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. **Service Providers shall be required to present** *their Tender Document at the above meeting for endorsing. Failure to comply with this condition will result in the Service Provider being disqualified. Further to this, Service Providers who arrive at the above meeting after the stipulated starting time will also be disqualified.* 

Sealed tenders endorsed on the envelope "<u>SPECIALISED CONTRACT No. SCM 19 OF</u> <u>11/12</u>" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00 on Thursday**, **1 December 2011**. Only tenders placed in the tender box shall be accepted.
