The period of contract shall be for thirty six (36) months commencing on 06 February 2013 and terminating on 05 February 2016.

The tendered rates shall remain firm for a period of twelve (12) months and thereafter be subject to escalation based on the Consumer Price Index (CPIX).

Please note that your attention is specifically drawn to the provisions of Regulation 44 of the Municipal Supply Chain Management Regulations and the Msunduzi Municipality's Supply Chain Management Policy which prohibits any award to a person:-

You are expressly advised that any award in contravention of the above would be in direct conflict with the aforesaid Legislation and shall be deemed void and without any legal effect.



