Only one site inspection meeting will be held. **Tenderers arriving at the meeting after the stipulated starting time will be disqualified.** An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. **Tenderers shall be required to present their Tender Document at the above meeting for endorsing. Failure to comply with this condition will result in the Tenderer being disqualified. Further to this, Tenderers who arrive at the above meeting after the stipulated starting time will also be disqualified.***
