DISPOSAL OF 10 GIRAFFE, 20 ZEBRA AND 40 WILDEBEEST FROM BISLEY VALLEY NATURE RESERVE AND THE ACQUISITION OF A ZEBRA STALLION AND A GIRAFFE BULL FOR RELEASE INTO BISLEY VALLEY NATURE RESERVE

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced Service Providers for the disposal of 10 giraffe, 20 zebra and 40 wildebeest from Bisley Valley Nature Reserve and the acquisition of a zebra stallion and a giraffe bull for release into Bisley Valley Nature Reserve.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Wednesday, 22 June 2015**. A non-refundable tender fee in the amount **R425.22 (including VAT) per document** shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Site Inspection Meeting will be held on site, on **Wednesday, 29 July 2015**, commencing at **10h30**. Prospective tenderers shall meet at the **entrance of the Bisley Valley Nature Reserve, situated in Gladys Mzansi Road (Murray Road), Bisley**, (GPS point of the entrance: -29.656610, 30.395664), the nearest intersection to the entrance being Gladys Mzansi Road (Murray Road) and Alexandra Road. Only one Site Inspection Meeting will be held. An official will chair the meeting and answer any queries raised by prospective tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed tenders endorsed on the envelope with **“Contract No. SCM 2 of 15/16”** and the relevant Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on Thursday, 06 August 2015**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Three (3) months commencing from the closing date of tender.

Tender Adjudication/Evaluation Criteria: The tender shall be evaluated in terms of the mandatory compliance requirements of the tender and thereafter the 80/20 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.

The Msunduzi Municipality does not bind itself to accept the lowest or any tender and reserves the right to accept the whole or any part of a tender.

Each tenderer will be informed of the tender result. The Msunduzi Municipality expects businesses within the Pietermaritzburg and Midlands Region to support its contract and BEE/SMME initiatives.
