#### SPECIALISED CONTRACT No. SCM 51 OF 15/16

#### SERVICE MIDLOCK ERADICATION IN IMBALI (WATER) CONSTRUCTION OF APPROXIMATELY 2.2KM WATER RETICULATION PIPELINE WITH ASSOCIATED VALVES AND FITTINGS AND 394 WATER METER HOUSE CONNECTIONS IN IMBALI, WARD 19, PIETERMARITZBURG

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced Contractors to undertake the construction of approximately 2.2km water reticulation pipeline with associated valves and fittings and 394 water meter house connections in Imbali, Ward 19, Pietermaritzburg.

**Only Contractors registered with the Construction Industry Development Board (CIDB) with a Contractor Grading of 4CE, or higher, shall be eligible to submit tenders.**

Tender documents shall be available from the Supply Chain Management Unit Offices, 5<sup>th</sup> Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Tuesday, 31 May 2016**. A non - refundable tender fee in the amount **R425.22 (including VAT) per document** shall be levied. Only cash or bank guaranteed cheques will be accepted.

**A compulsory Tender Briefing Meeting** chaired by the appointed Consulting Engineer will be held on **Thursday, 09 June 2016**, at the Imbali GEDI Offices, Corner of Sutherlands and F.J. Sithole Roads, Imbali, commencing promptly at **10h30**. Thereafter, all shall travel in convoy to site for a Site Inspection. Only one Tender Briefing Meeting and Site Inspection will be held. ***Tenderers arriving at the meeting after the stipulated starting time above will be disqualified. Further, all Tenderers attending the meeting must be in possession of a Tender Document, failing which the Tenderer shall be disqualified.***

Sealed tenders endorsed on the envelope with “**Specialised Contract No. SCM 51 of 15/16**” and the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on Monday, 27 June 2016**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Three (3) months commencing from the closing date of tender.

**Tender Adjudication/Evaluation Criteria:** The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 90/10 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-
