The Msunduzi Municipality hereby invites tenders for the above works. **Only tenderers with a CIDB Contractor grading of 4GB or higher, who have the relevant expertise, capacity, experience and/or construction equipment, shall be eligible to submit tenders.**

Only one compulsory Clarification Meeting will be held. ***Tenderers arriving at the meeting after the stipulated starting time will be disqualified.*** No tender shall be accepted from tenderers who do not attend the above meeting. Tenderers will be required to present their tender document at the Clarification Meeting.

Sealed tenders endorsed on the envelope "**Specialised Contract No. SCM 5 of 14/15**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on Friday, 26 September 2014**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Four (4) months commencing from the closing date of tender.

**Tender Evaluation Criteria:** The tender shall be evaluated on the 90/10 Preferential Points System and in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.
