#### PROPOSAL CALL FOR THE APPOINTMENT OF AN IMPLEMENTING AGENT TO UNDERTAKE THE FEASIBILITY AND PLANNING OF THE JIKA JOE AND SURROUNDING LAND PARCELS AND THE IMPLEMENTATION OF APPROXIMATELY 1000 COMMUNITY RESIDENTIAL UNIT (CRU) PROJECT FOR THE TATHAM SPORTS GROUND

Proposals are hereby invited from suitably qualified and experienced Tenderers for the above works.

A compulsory Tender Briefing meeting will be held at 10h30 prompt on Friday, 6 September 2013, in the Housing Unit Boardroom, 5<sup>th</sup> Floor, A S Chetty Building, 333 Church Street, Pietermaritzburg, 3201. Only one Tender Briefing meeting will be held. ***Tenderers arriving at the meeting after the stipulated starting time will be disqualified.*** An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed tenders endorsed on the envelope "**Specialised Contract No. SCM 9 of 13/14**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, 3201, not later than **12h00 on Monday, 16 September 2013**, when they will be opened in public. Only tenders placed in the tender box shall be accepted. Under no circumstances whatsoever will any extension of time be allowed for submission of tenders.

**Tender Validity Period:** Ninety (90) days commencing from the closing date of tender.

**Tender Evaluation Criteria:** The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on the 90/10 Preferential Points System in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.
