Tenderers shall be required to meet at the entrance of the market on the date and time mentioned above. Only one site inspection meeting will be held. ***Tenderers arriving at the meeting after the stipulated starting time will be disqualified.*** An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed tenders endorsed on the envelope "**Specialised Quotation No. Q87 OF 12/13**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, 3201, not later than **12h00 on Wednesday, 6 March 2013**. Only tenders placed in the tender box shall be accepted.

The Validity period shall hold firm for ninety (90) days commencing from closing date of the tender.
