A compulsory Clarification Meeting will be held on site on **Tuesday 03 April 2012**. Prospective tenderers shall meet at the **Supply Chain Boardroom 5th Floor AS Chetty BLD, 333 Church Street, at 10h00**. Only one Clarification Meeting will be held. An official will chair the meeting and answer queries raised by prospective Service Providers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. **Tenderers who come after the stipulated starting time will not be allowed to be part of the meeting**. No tender shall be accepted from tenderers who do not attend the above meeting.

Sealed tenders endorsed on the envelope "Quotation No. SCM Q 52 of 11/12" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, **not later than 12h00 on Tuesday, 10th April 2012**. Only tenders placed in the tender box shall be accepted.

The validity period for which the tender is to hold firm is a period of ninety (90) days from closing date of tender.

Evaluation and adjudication of the tender will be done in line with the Msunduzi Municipality's approved Supply Chain and Preferential Procurement Policies on an 80/20 point system. Adjudication criteria will be as per the tender document; the allocation of points will be done in line with B-BBEE as prescribed in terms of the Preferential Procurement Regulations, 2011 pertaining to the Preferential Procurement Policy Framework Act, Act No 5 of 2000.

The Msunduzi Municipality does not bind itself to accept the lowest or any tender, and reserves the right to accept the whole or any part of a tender. Each tenderer will be informed of the tender result.
