Item 12:

The Bidder shall submit certified copies of all Dog licenses and permits issued in terms of Performing Animals Protection Amendment Act, No 4 of 2016. (PAPA) and/or a proof of licenses and registration or intention to subcontract dogs, an intention to subcontract/ or lease must be signed by both parties accompanied by the certified copy of a valid license from subcontractor or lessor.

Item 14:

The Bidder shall submit proof of NKP (National Key Points) registration/accreditation, (More Specifically relating electricity sub stations and electricity cables) certified and issued in accordance with PSIRA.

Please note that this requirement is removed.

Item 15:

The Service Provider shall submit certified copies of proof of ownership or provide certified copies of lease agreements in respect of at least ten roadworthy vehicles. The Service Provider shall be either the owner or the lessee of such vehicles. The Service Provider must in addition submit certified copies of the registration certificates and roadworthy certificates of the vehicles with the tender. Vehicles must have at least a 1600 cc engine capacity and 4x2 drive.

If leased, the signed intent by both parties to lease must be accepted, the intent must be in the name of the service provider and logbook from the lessor or potential lessor must be attached. The requirement does not exclude any service provide.
