### ANNEXURE 5: SUBSTATION TEAM

- a) **One 10 tonne (minimum)** truck, 1.5 tonne Panel Van or 1.5 tonne LDV or 1 tonne LDV with tow hitch, ladder racks, suitable storage facilities inside the vehicle for all the necessary tools and equipment and a canopy. The vehicles shall have a certificate of road worthiness in terms of the Road Traffic Act; **(Proof of Ownership (logbook) or proof of access/hire.**

A set of tools and equipment required for construction of medium and low voltage substations.

### ANNEXURE 6: OVERHEAD MAINS TEAM

- d) **One 10 tonne (minimum)** truck, 1.5 tonne Panel Van or 1.5 tonne LDV or 1 tonne LDV with tow hitch, ladder racks, suitable storage facilities inside the vehicle for all the necessary tools and equipment and a canopy. The vehicles shall have a certificate of road worthiness in terms of the Road Traffic Act; **(Proof of Ownership (logbook) or proof of access/hire**

A set of tools and equipment required for construction of medium and low voltage transmission lines.

### ANNEXURE 7: UNDERGROUND MAINS TEAM

- d) **One 10 tonne (minimum)** truck, 1.5 tonne Panel Van or 1.5 tonne LDV or 1 tonne LDV with tow hitch, ladder racks, suitable storage facilities inside the vehicle for all the necessary tools and equipment and a canopy. The vehicles shall have a certificate of road worthiness in terms of the Road Traffic Act; **(Proof of Ownership (logbook) or proof of access/hire**

A set of tools and equipment required for construction of medium and low voltage underground mains.

## **12. MATERIALS**

**NOTE:** It will be mandatory for all the materials that have a minimum threshold of the local content and production that the service provider complies with those requirements at the time of purchasing. Local content declaration forms shall be completed and signed by the service provider upon each project being undertaken should there be a need to procure such materials that require compliance with the local content and production requirements as per the Department of Trade, Industry and Competition.
