MECHANICAL WATER TREATMENT CONTRACT (CHEMICAL DOSING)

The Msunduzi Municipality hereby invites suitably qualified and experienced tenderers for the above works. ***Only Contractors who have a CIDB Grading of 1ME/1EB or higher will be eligible to tender.***

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **14h30 on Tuesday, 3 November 2015**. A non - refundable tender fee in the amount R425.22 (including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Briefing meeting will be held at 10h00 prompt on Thursday, 12 November 2015, in the Exco Boardroom, 4th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, 3201. Only one compulsory Clarification Meeting will be held. ***Tenderers arriving at the meeting after the stipulated starting time will be disqualified.*** An official will chair the meeting and answer queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. ***Tenderers must present their tender document at the meeting failing which the Tenderer shall be disqualified.***

Sealed tenders in endorsed on the envelope “**Supplies and Services Contract No. 29 of 2015: Section D**” must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on 1 December 2015**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Four Months **days** commencing from the closing date of tender.

Tender Evaluation Criteria: The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on the 80/20 Preferential Points System in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000. The Functionality for Stage 1 shall be as follows:-
