#### MAINTENANCE AND REFURBISHMENT TO STANDBY GENERATORS FOR MSUNDUZI MUNICIPAL BUILDINGS

The Msunduzi Municipality hereby invites tenders for the above works for a three (3) year period. **Only tenderers with a CIDB Contractor grading of 2ME/2EB or higher, who have the relevant expertise, capacity and experience, shall be eligible to submit tenders.**

Tender documents shall be available from the Supply Chain Management Unit Offices, 5<sup>th</sup> Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **14h00** on **Monday, 9 November 2015**. A non-refundable tender fee in the amount **R425.22** (Inc. VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Briefing meeting will be held at **10h00 prompt** on **Wednesday, 18 November 2015**, in the EXCO Boardroom, 4<sup>th</sup> Floor, A S Chetty Building, 333 Church Street, Pietermaritzburg. Only one compulsory Clarification Meeting will be held. **Note: Tenderers arriving at the meeting after the stipulated starting time will be disqualified.** No tender shall be accepted from tenderers who do not attend the above meeting. Tenderers will be required to present their tender document at the Clarification Meeting.

Sealed tenders endorsed on the envelope "**SUPPLY AND SERVICES CONTRACT No. 52 OF 2015**" with the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00**, on **Tuesday, 8 December 2015**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Ninety (90) days commencing from the closing date of tender.

**Tender Evaluation Criteria:** The tender shall be evaluated on a Two Stage Evaluation System. Stage 1 being Functionality and Stage 2 based on the 90/10 Preferential Points System in accordance with the Preferential Procurement Regulations, 2011 issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.
