SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING AND REPAIRS TO THE WATER AND SANITATION TELEMETRY INFRASTRUCTURE

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced Service Providers for the supply, delivery, installation, commissioning and repairs to the Water and Sanitation Telemetry Infrastructure.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00 on Wednesday, 22 June 2015**. A non - refundable tender fee in the amount **R425.22 (including VAT) per document** shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Tender Briefing Meeting will be held on **Monday, 27 July 2015**, in the **Water and Sanitation Boardroom, 3rd Floor, Professor Nyembezi Centre, 341 Church Street, Pietermaritzburg**, commencing at **10h30**. ***Prospective tenderers arriving at the meeting after the stipulated time will be disqualified.*** Only one Tender Briefing Meeting will be held. An official will chair the meetings and answer any queries raised by prospective Tenderers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register.

Sealed tenders endorsed on the envelope with **“Supply and Services Contract No. 71 of 2015”** and the relevant Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00 on Monday, 17 August 2015**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

Tender Validity Period: Three (3) months commencing from the closing date of tender.

Tender Adjudication/Evaluation Criteria: The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 90/10 Preference Point System in accordance with the Preferential Procurement Regulations, 2011, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-
