SUBJECT: SPATIAL PLANNING AND LAND USE MANAGEMENT ACT, 2016 OF 2013: REQUEST OF COUNCIL FOR THE ADOPTION OF THE SCOTTSVILLE AND SURROUNDS LOCAL AREA PLAN

3. BACKGROUND

- 3.1 The Spatial Planning and Land Use Management Act No. 16 of 2013 requires that Municipal Council must by notice in the Provincial Gazette adopt a Spatial Development Framework for the Municipality
- 3.2 The Spatial Development Framework (2015), a component of the Msunduzi Municipality Integrated Development Plan, proposes a suite of Plans for each local area to direct detailed planning. The Rural Development and Land Reform SDF guidelines define a Local Area Plan as a specific geographically smaller area with specific characteristics, (areas which require economic, physical and social renewal or areas likely to be subject to large scale development within the planning horizon.
- 3.3 At its meeting of which the Scottsville and Surrounds Local Area Plan Report dated 16 September 2020 by the General Manager Sustainable and Development Enterprises was stood down there was a request to double check the alignment between the Scottsville Local Area Plan and the Draft Spatial Development Framework, the Annexure is attached as Annexure "A".

- 3.4 According to the Msunduzi Integrated Development Plan, the Msunduzi Municipality has embraced the concept of Hierarchy of Plans. To date the following Plans have been adopted:
 - CBD, Ashburton and Eastern Areas Local Area Plans
 - The Vulindlela Local Area Plan
 - Northern Areas Local Area Plan
- In terms of context, the birth of Scottsville can be traced back to 1903 with the layout of the current plan having a huge resemblance of the initial 1903 layout, which was intended for a housing area that would accommodate the City's population growth.
- 3.6 Scottsville offers a number of schools while the University of KwaZulu Natal and Durban University of Technology are dominating the eastern section of the study area hence creating a demand in student housing and other related uses such as commercial sites.

- In respect of the above table, it should be noted that the report for the adoption of the Scottsville Local Area Plan was withdrawn in terms of Minute dated 16 February 2021 from Council pending alignment to the Spatial Development Framework (2015), which was being reviewed and further studies of the context of the Scottsville and Surrounds Precinct including updated Land Use Study.
- 5.2 It should be noted that further work was done by the business unit and hence is now satisfied that that there is alignment between the Scottsville Local Area Plan and the Draft Spatial Development Framework.
