SUPPLIES AND SERVICES CONTRACT No. E16 OF 2021

SUPPLY AND DELIVERY OF STREET LIGHTING POLES AND ACCESSORIES

The Msunduzi Municipality hereby invites tenders from Service Providers who have the relevant expertise and capacity for the supply and delivery of street lighting poles and accessories on an 'as and when' required basis. The Contract must comply with the 'Department of Trade and Industry' stipulated minimum threshold of 100% Local Content. Only Service Providers with BBBEE levels 1 and 2 will be considered.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **15h00 on Monday, 8 November 2021**. A non-refundable tender fee of **R 598.00** (Inc. VAT) per document shall be levied. Only cash, bank guaranteed cheques or EFT payments will be accepted. A copy of the Tender Deposit Receipt must be attached to the tender document (if purchased at the Municipality).

Tenders must be submitted together in hard copy and on a CD/USB Flash Drive contained in sealed envelopes and marked with "**SUPPLIES AND SERVICES CONTRACT No. E16 OF 2021**" and **DESCRIPTION**, must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00, on Tuesday, 7 December 2021**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted. Under no circumstances whatsoever will any extension of time be allowed for submission of tenders.

Tender Validity Period

Four (4) months commencing from the closing date of tender.

Tender Evaluation Criteria

The tender shall be evaluated on the 80/20 Preferential Points System in accordance with the Preferential Procurement Regulations, 2017, issued in terms of section 5 of the Preferential Procurement Policy Framework Act No. 5 of 2000.

The Msunduzi Municipality does not bind itself to accept the lowest or any tender, and reserves the right to accept the whole or any part of a tender. Each tenderer will be informed of the tender result. The Msunduzi Municipality expects businesses within the Pietermaritzburg and Midlands Region to support its contract and BEE/SMME initiatives.
