Only tenderers with CIDB grading of 6SQ or higher and who are B-BBEE Level 1 and 2 Contributors will be considered for appointment.

A non-refundable tender fee in the amount **R905.05**(Inc. VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted. A compulsory Tender Briefing Meeting will be held on **Tuesday, 17 September 2019**, in the **PMB Airport Boardroom, 2nd Floor, 1 Pharazyn Way, Oribi**, commencing promptly at **10h30**. ***Tenderers arriving at the meeting after the stipulated starting time above will be disqualified. Further, all Tenderers attending the meeting must be in possession of a complete tender document failing which the Tenderer shall be disqualified. Tenderers producing only the Tender Briefing Certificate at the meeting will not be considered.*** Only one representative per Company or Consortium will be allowed to attend the above meeting.

Sealed tenders endorsed on the envelope "**Contract No. SCM 13 of 19/20**" with the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00**, on **03 October 2019**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted

Tender Validity Period: Four (4) months commencing from the closing date of tender.

Tender Evaluation Criteria: The tender shall be evaluated on a Two Stage Evaluation System – Stage One Functionality and Stage Two 80/20 Preference Point System in accordance with the Preferential Procurement Regulations, 2017, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.

Functionality for Stage One shall be evaluated on the following criteria:		Maximum Points
1	Bank Rating	10
2	Number of completed projects for supply and installation of clearVu Fence	40

Total Functionality Points	50 Points
Threshold to qualify for Stage Two : 70%	35 Points
