APPOINTMENT OF A PANEL OF ACCREDITED TRAINING PROVIDERS

The Msunduzi Municipality in line with the Work Place Skills Plan hereby invites tenders from accredited Service Providers to conduct specialised training in various learning interventions for a three (3) year period.

Tenders must be submitted together in hard copy and on a CD/USB Flash Drive contained in sealed envelopes and marked with the **"SPECIALISED CONTRACT No. SCM 28 OF 21/22"** and the **Contract Description**, must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00, on Wednesday, 10 November 2021**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted. Under no circumstances whatsoever will any extension of time be allowed for submission of tenders.

Tender Validity Period

Four (4) months commencing from the closing date of tender.

Tender Evaluation Criteria

The tender shall be evaluated on the 80/20 Preference Point System in accordance with the Preferential Procurement Regulations, 2017, issued in terms of Section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.

The Msunduzi Municipality does not bind itself to accept the lowest or any tender, and reserves the right to accept the whole or any part of a tender. Each tenderer will be informed of the tender result.
