**TENDER NOTICE**

The Msunduzi Municipality hereby invites tenders from suitably qualified and experienced contractor for the construction for upgrading of 0.5 km long by 5 metres wide, Makhathini access road from dirt to concrete road surfacing in Willowfountain – Ward 14

**Only tenderers with minimum of CIDB grading of 5CE or higher will be considered for appointment.**

It is compulsory for all interested tenderers to download a **Tender Registration Form** in order to purchase the tender document. from the Supply Chain Management Unit Offices, 5<sup>th</sup> Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg at a non-refundable tender deposit fee of **R946.45 (including VAT)** for each document drawn. Only cash or EFT payments will be accepted.

The Tender Registration Form is available on the Municipality's website **[www.msunduzi.gov.za](http://www.msunduzi.gov.za)** in the Tenders Folder. The registration will start from **Thursday, 05 August 2021** until **Thursday, 19 August 2021** at **12h00**.

**No tender registration will be considered after the above closing date and time for registration. Tenderers who fail to register within the registration period will not be eligible to purchase tender document and to submit their respective tender documents when the tender closes.**

**Virtual Briefing Meeting** will be on **Friday, 20 August 2021**; tenderers will thereafter receive an email from **Phiwe Mthalande** with the link.

The Municipality will continue to advertise its Tender Notices in the National Treasury eTender Portal and Municipal website, but the tender documents will be available to potential tenderers that submitted their Tender Registration Form on time.

**Tenders must be submitted both in hard copy and on CD/USB flash Drive contained in sealed envelopes and marked with “Contract No. SCM 6 OF 21/22”** with the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00**, on **08 September 2021**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

**Tender Validity Period:** Four (4) months commencing from the closing date of tender.

**Tender Adjudication/Evaluation Criteria:** The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 80/20 Preference Point System in accordance with the Preferential Procurement Regulations 2017, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:-

1	Number of roads & associated storm water with kerb and channel projects completed by the bidder	20 Points
2	Construction Manager/ Site Agent	40 Points
3	Construction Supervisor/Foreman	40 Points
4	Labour Intensive Construction Certificate for Construction Manager or Construction Supervisor Plant	15 Points
5	Resources: Plant equipment: The bidder must indicate if it has the working plant equipment and operators with expertise in operating the plant, to comply with the requirements of the contract.	20 Points

<b>Threshold to Qualify for Stage Two</b>		<b>(81Points) 60%</b>
