The Msunduzi Municipality hereby invites tenders from Contractors registered with the Construction Industry Development Board for the above works categorised under the following Sections and required CIDB levels: -

SECTION 1	NON-ITEMIZED / SPECIFIED / EMERGENCY WORK	1 GB to 3 GB or HIGHER
SECTION 2	REPAIRS / REFURBISHMENT / ALTERATIONS AND NEW WORKS	1 GB to 3 GB or HIGHER
SECTION 3	FENCING	1 SQ to 3 SQ or HIGHER

Tender documents shall be available from the Supply Chain Management Unit Offices, 5<sup>th</sup> Floor, A S Chetty Centre, 333 Church Street, Pietermaritzburg, from **15h00 on Wednesday, 17 January 2024**. A non-refundable tender fee in the amount **R 287.68** (Inc. VAT) per document shall be levied. Only cash or electronic fund transfers will be accepted. Tender documents can be downloaded and printed at the Tenderer's cost from the National Treasury e-Tender Publication Portal on [www.etenders.gov.za](http://www.etenders.gov.za).

**A non-compulsory Tender briefing meeting** will be held on **Tuesday, 30 January 2024** at the Bessie Head Library – Auditorium, 1st Floor, 260 Church Street, Pietermaritzburg, commencing promptly at 10h00.

Tenders must be submitted together in hard copy and on a CD/USB Flash Drive contained in sealed envelopes and marked with **"SUPPLIES AND SERVICES CONTRACT No. 72 OF 2024"** and Description, must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than **12h00, on Wednesday, 14 February 2024**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted. Under no circumstances whatsoever will any extension of time be allowed for submission of tenders.

**Tender Validity Period:** Four (4) months commencing from the closing date of tender.

**Tender Evaluation & Adjudication Criteria:** The tender shall be evaluated on a Two Stage Evaluation System, Stage One Functionality and Stage Two 80/20 Preference Point System as prescribed in terms of the Preferential Procurement Regulations 2022, pertaining to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.
