#### **TENDER NOTICE**

The Msunduzi Municipality hereby invites proposals from specialist contractors for the Desilting of the Camps Drift Canal in the Msunduzi Municipality. ***The specialist contractors must have a minimum CIDB Grading of 8CE.***

Interested tenderers are to submit a **Tender Registration Form** of which is available on the Msunduzi Municipality's website [www.msunduzi.gov.za](http://www.msunduzi.gov.za) in the Tenders Folder / Database Forms. The registration will begin from **30 November 2020** and end on **04 December 2020** at **23h59**. The Tender Registration Form must be completed and emailed to [procurement@msunduzi.gov.za](mailto:procurement@msunduzi.gov.za). ***Tenderers who fail to register within the above registration period will not be eligible to submit a tender document.***

Tenderers will be informed in due course of the mode and details of the **Compulsory Tender Clarification Meeting** once potential tenderers have submitted their Tender Registration Forms. Tenderers that do not receive confirmation within 24 hours before the end of the above registration date shall request such via email to [procurement@msunduzi.gov.za](mailto:procurement@msunduzi.gov.za). The Municipality will continue to advertise its Tender Notices on the National Treasury e-Tender Portal and Municipal website. Tender documents will only be emailed to potential tenderers that have submitted their Tender Registration Forms on time.

**Tenders must be submitted in the original format plus one hard copy and in softcopy format on either a CD or USB Flash Drive together with the original bid document, contained in sealed envelopes and marked with "Contract No. SCM 35 of 20/21" and the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (formerly Commercial Road), Pietermaritzburg, 3201, not later than 12h00 on Monday, 18 January 2021, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted.**

**Tender Validity Period:** 120 days commencing from the closing date of tender.

**Tender Adjudication/Evaluation Criteria:** The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 90/10 Preference Point System in accordance with the Preferential Procurement Regulations 2017, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:

1.	Submission of a separately bound, properly indexed volume for compulsory Returnable documents with the Bid	10 Points
2.	Technical experience of the Bidder in similar projects	60 Points

3.	Professional Registration and experience of the proposed Contracts Manager in similar projects	15 Points
4.	Qualifications and experience of the proposed Construction Manager (formerly known as Site Agent) in similar projects	10 Points
5.	Experience of the proposed General Foreman in similar projects	10 Points
6.	Registration with SACPCMP and experience of the proposed Safety Officer in Construction projects	5 Points
7.	Bidder's plant vital for the execution of the Works	40 Points
<b>Total Functionality Points</b>		<b>150 Points</b>
<b>Threshold to Qualify for Stage Two</b>		<b>70 % (105 Points)</b>
