**Tender Evaluation & Adjudication Criteria:** The tenders shall be evaluated on the 80/20 Preference Point System as prescribed in terms of the Preferential Procurement Regulations 2022, pertaining to the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.
