Tenders must be submitted both in hard copy and on a CD/USB Flash Drive contained in sealed envelopes and marked with "Contract No. SCM 37 of 20/21" and the Contract Description must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (Commercial Road), Pietermaritzburg, not later than 12h00, on Thursday, 04<sup>th</sup> March 2021. Only tenders placed in the Tender Box shall be accepted.

<u>Tender Validity Period</u>: Four (4) months commencing from the closing date of tender.

<u>Tender Adjudication/Evaluation Criteria</u>: The tender shall be evaluated on a Two Stage Evaluation System – Stage One: Functionality and Stage Two: 80/20 Preference Point System in accordance with the Preferential Procurement Regulations 2017, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000. The Functionality for Stage One shall be evaluated on the following criteria:

Threshold for 5CE or higher = 70% or minimum of 87,5 points for bidder to be selected to participate in a close tender process.

Threshold for 3CE to 4CE = 50% or minimum of 62,5 points for bidder to be selected to participate in a close tender process.

Threshold for 2CE = 30% or minimum of 37,5 points for bidder to be selected to participate in a close tender process.
