**APPOINTMENT OF A FACILITIES MANAGEMENT COMPANY TO MANAGE,
MAINTAIN AND REPAIR THE MSUNDUZI RENTAL HOUSING**

Tenders are hereby invited from suitably qualified and experienced Service Providers to provide comprehensive facilities management services for the Msunduzi Municipality's rental housing. ***Only Service Providers who are B-BBEE Level 1 and 2 Contributors will be considered for appointment.***

Tender documents will be available to Tenderers from **10h00 on Tuesday, 19 September 2017.**

A compulsory Tender Briefing Meeting will be held at 10h00 prompt on Friday, 6 October 2017, in the Human Settlements Boardroom, 4th Floor, Gallwey House, 19 Gallwey Lane, Pietermaritzburg, 3201, from where all will proceed in convoy to the site/s. ***Service Providers arriving at the meeting after the stipulated starting time mentioned above will be disqualified.*** Only one Tender Briefing/Site Inspection Meeting will be held. An official will chair the meeting and answer queries raised by prospective Service Providers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. Only one (1) Representative per Company or Joint Venture or Consortium will be allowed to attend the above meeting. ***Service Providers attending the meeting must be in possession of a Tender Document failing which the Service Provider shall be disqualified.*** No Tenderer will be allowed to represent more than one (1) Company at the meeting.

No Service Provider will be allowed to purchase or collect tender documents after 14h00 on 5 October 2017, and the Msunduzi Municipality will not be held liable for any loss or damages sustained by the Tenderer in this regard.

Tenders contained in sealed envelopes and marked with "**Contract No. 26 of 17/18**" and the **Contract Description** must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street (formerly Commercial Road), Pietermaritzburg, 3201, not later than **12h00 on 18 October 2017**, when they will be publicly opened. Only tenders placed in the Tender Box shall be accepted. Under no circumstances whatsoever will any extension of time be allowed for submission of tenders.

Tender Validity period: Three (3) months commencing from the closing date of the tender.

Tender Adjudication/Evaluation Criteria: The tender shall be evaluated on a Two Stage Evaluation System – Stage One being Functionality and Stage Two being the 80/20 Preference Point System in accordance with the Preferential Procurement Regulations, 2017, issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act No. 5 of 2000.
