Tenders are hereby invited from suitably qualified and experienced service providers for the Upgrading of East Street Public Ablutions Facilities for Male and Females. Only tenderers registered IOPSA or any recognized Plumbing Institute will be considered.

Tender documents shall be available from the Supply Chain Management Unit Offices, 5th Floor, A. S. Chetty Centre, 333 Church Street, Pietermaritzburg, from **12h00** on **Thursday, 28 March 2013**. A non-refundable tender fee in the amount **R 119.70** (Including VAT) per document shall be levied. Only cash or bank guaranteed cheques will be accepted.

A compulsory Clarification Meeting will be held on site on Wednesday, 03 April 2013. Prospective tenderers shall meet at the Supply Chain Boardroom 5th Floor AS Chetty Building, at 10h00. Only one Clarification Meeting will be held. An official will chair the meeting and answer queries raised by prospective Service Providers. Any amendment to the tender documentation arising from such answers will be circulated in terms of the meeting's attendance register. Tenderers who come after the stipulated starting time will not be allowed to be part of the meeting. No tender shall be accepted from tenderers who do not attend the above meeting.

Sealed tenders, endorsed on the envelope "**QUOTATION No. SCM Q94 OF 12/13**" must be placed in the Tender Box located in the Foyer, Ground Floor, City Hall, 169 Chief Albert Luthuli Street, Pietermaritzburg, not later than **12h00**, on **Monday, 08 April 2013**, when it will be publicly opened. Only tenders placed in the Tender Box shall be accepted.

The Validity period shall hold firm for ninety (90) days commencing from closing date of the tender.

Tender Adjudication & Evaluation Criteria will be implemented in line with the Msunduzi Municipality's approved Supply Chain and Preferential Procurement Policies on the **80/20** point system. Adjudication criteria will be as per the tender document, the allocation of points will be in line with **B-BBEE** as prescribed in terms of the Preferential Procurement Regulations, 2011 pertaining to the **Preferential Procurement Policy Framework Act**, Act No. 5 of 2000.
